

PUBLIC NOTICE

Notice is hereby given pursuant to Section 19 of the Foreshore Act, 1933 that Irish Water has applied to the Minister of Housing, Planning and Local Government for a licence under Section 3 of the said Act for the Site Investigations for Sewerage Scheme, Roundstone Bay, Galway.
