- **1. Specified Purpose:** The personal data sought from you is required for the purpose of terminating the arrangement between the scheme applicant and the agricultural agent for the scheme(s) selected on this form.
- **2. Legal Basis**: The legal basis for processing this personal data is Article 6(1) (b), (c) and (e) of Regulation (EU) 2016/79 of the European Parliament and of the Council of 27 April 2016 (the General Data Protection Regulation) i.e. processing is necessary for the performance of a contract to which the data subject is party or in order to take steps at the request of the data subject prior to entering into a contract, compliance with a legal obligation to which the controller is subject and for the performance of a task carried out in the public interest or in the exercise of official authority vested in the controller.
- **3. Recipients**: Information provided on this form will be shared with other Business Areas within the Department to ensure that the agent(s) listed will no longer be in a position to act on behalf of the scheme applicant for the scheme(s) selected.
