BALTIMORE PUMPING STATION

DESCRIPTION OF THE WORKS

It is proposed to construct a pumping station beside the existing septic tank which is located between the North Pier and the Bull Point close to the Glenans Sailing School and Old Railway Station. This pumping station will have stormwater storage facilities to limit the likelihood of overflow of untreated effluent to the bay. The pump control and metering equipment panels will be housed in a kiosk. Mitigation measures will be taken to maintain noise and odour emissions within recognised and acceptable limits. This pumping station will transfer the wastewater from the Baltimore Sewerage Scheme collection system to the proposed wastewater treatment plant at Bull Point.

It is proposed that the pumping station will be procured through a Design, Build and Operate form of contract along with the wastewater treatment plant. An indicative layout of the works is included in Dwg. No.1339 –2(BM)-P02. The final layout of the site will be governed by the contractor's proposals for the site.

Paved areas will consist of concrete pavement and macadam with block paviors to hard landscaped areas.

A connection from the Baltimore water supply scheme will be taken from the adjacent public main to the pumping station site. Power supply will be brought to the site from the nearest available location.
