FORESHORE LICENCE

The Minister for Communications, Marine and Natural Resources (hereinafter referred to as the Minister) in exercise of the powers conferred on him by Section 3 (3) of the Foreshore Act, 1933 (No. 12 of 1933) hereby authorises:-

Mr Frank Melvin, Carraig Fhada Seaweed, Rathlee, Easkey, Co Sligo to harvest not more than 47 (forty seven) tons of seaweed from the foreshore at coastal areas between Aughris Head and the townland of Kilglass, Co Sligo as outlined on the attached map.

This Licence is granted subject to the following conditions:

- 8. The Licence is valid for one year from 28th March 2006 but may be revoked before then at twenty-four hours notice.
- 9. Cutting of seaweed shall not take place outside of the normal harvesting periods of late spring and summer and no cutting shall take place after 31 July 2006.
- 10. Seaweed must only be removed from the areas delineated in green on the attached map.
- 11. The Licensee shall only harvest the species and quantities of seaweed as stated on the attached schedule.
- 12. The use of mechanical methods of harvesting is prohibited.
- 13. To facilitate regeneration of the seaweed at the areas harvested, the Licensee shall ensure that the bottom 10-15 cms of the plant is not harvested.
- 14. The Licensee shall indemnify and keep indemnified and hold harmless, the State, the Minister and his officers, agents and employees against all actions, loss, claims, damages, expenses and demands arising in any manner whatsoever in connection with
 - iv) the grant of this Licence;
 - v) the performance of works in the Licence Area by the Licensee or its servants, agents, employees or contractors or;
 - vi) the exercise of any rights or performance or non-performance of any obligations pursuant to this Licence.

- vi) the exercise of any rights or performance or non-performance of any obligations pursuant to this Licence.
- 8. The Licensee shall comply with all lawful instructions given by the Heritage and Planning Division of the Department of the Environment, Heritage and Local Government in relation to all seaweed harvesting to be carried out within the area covered by this Licence and, in the event that the Licensee disputes any such instruction, no harvesting shall commence or be undertaken without the prior consent of the Minister for Communications, Marine and Natural Resources which will only be given following consultation with the Heritage and Planning Division.
