# Full year 2020

# 1. Agri-food sector trade - Exports



Ireland is an open economy which exports the majority of its agricultural products. Irish exports of agri-food products accounted for 8.7% of total merchandising exports, with the value of agri-food exports for 2020 totalling €14.1 billion. This is down -3.3% in value and -1.2% in volume on 2019 figures, mainly due to a reduction in exports of forestry and beverages. Export values are driven by growth of Dairy up €21m (0.4%) , Sheep meat up €36m (+11.5%), Animal Foodstuffs up €24m (+6.6%) and Animal oils and fats up €16m (+27.8%), and Fruit and Vegetables up €16m (+10.1%). On the other side values for Beverages were down €263m (-15.3%), Live animals down €114m (-25.0%), beef down €47m (-2.0%), Fish exports down €56m (-9.8%), Poultry down €36m (-2.3%), and Sugar, Sugar Preparation & Honey down €30m (-19.5%).







# 2. Detailed Monthly analysis agri-food exports by type




Dairy produce exports totalled over €5.1 billion in 2020, a 0.4% increase on 2019 figures.





Beef exports totalled over €2.3 billion in 2020, a 2% decrease on 2019 figures.







Beverage exports totalled over €1.45 billion in 2020, a 15% decrease on 2019 figures.



Other meat exports totalled just under €1.5 billion in 2020. This includes Pigmeat exports €886m, sheep meat exports €354m and poultry exports at €255m. A slight 0.3% decrease on 2019 figures.









Seafood exports totalled over €520 million in 2020, a 9.8% decrease on 2019 figures.






Cereal & Cereal Prep exports totalled €537 million in 2020, a slight 0.3% increase on 2019 figures.



Forestry exports totalled €419 million in 2020, a 2.6% decrease on 2019 figures.






# 3. Agri-food sector trade - Imports




The agri-food sector accounted for 11.9% of Ireland's total imports in 2020. Between the period 2017 – 2020 agri-food imports increased by €1.1bn or 11%. Agri-food imports totalled over €10.1 billion in 2020, an increase of 1.5% on 2019 figures. The top five agri-food categories by value accounted for 50% of total agri-food sector imports in 2020 totalling over €5 billion. See pie chart below.

Prepared consumer foods are value added food and beverage products, which sell both domestically and internationally to retail, food service or other food companies. These goods are categorised into 15 areas identified and agreed by industry stakeholders, Department of Agriculture, Food and the Marine and the Central Statistics Office.


## 4. Prepared Consumer Foods



The Prepared Consumer Foods sector accounted for over €2.5 billion in agri-food sector exports in 2020, and €3.7 billion in imports. This resulted in a trade deficit of just over €1.2 billion. Between the period 2012 – 2020 prepared consumer food exports increased by over 25% from €2 billion to over €2.5 billion. Overall exports of Irish Prepared Consumer Foods decreased by 7.3% between 2019 and 2020.





#### Prepared Consumer Food Exports by month 2017—2020



Agri-food sector trade is broken down into 26 categories identified and agreed by Department of Agriculture, Food and the Marine and the Central Statistics Office. Products and Raw Goods are categorised using combined nomenclature (CN) codes, a European harmonised system used to classify goods for customs and trade reasons. These categories include non edible Agri-food items such as Forestry and Animal Hides and Skins (not included as part of Bord Bia trade statistics), along with traditional Food and Beverage products. While every effort has been made to ensure the accuracy of the data contained within, in view of the volume of statistical data collected as part of agri-food trade statistics, some errors in respect of individual products may occur. Where these anomalies are identified, the Department will liaise with the Central Statistics Office to highlight and amend the information as required. March 2021
