Foreword

I am very pleased to publish, in accordance with section 27 of the Children First Act 2015, this second Sectoral Implementation Plan for the Department of Children, Equality, Disability, Integration and Youth. The Plan describes the range of services for children provided directly or funded by my Department, and sets out the programme of measures in place to ensure compliance with the Children First legislation and guidance in respect of those services.

My Department conducted a review of its first Sectoral Implementation Plan in early 2021, as required by the Act. This involved an audit of compliance with Children First obligations by all units of the Department, including those in the areas of equality, disability policy and integration which transferred in from the Department of Justice last October. Units were also reminded to have regard to the addendum to the Children First National Guidance (published in January 2019), which clarifies that organisations providing relevant services to children need to consider online safety risks in the context of preparing Child Safeguarding Statements.

The Children First Act 2015 has been fully commenced since December 2017 and provides for a number of key child protection measures, including improving child protection arrangements in organisations providing services to children. Of central importance here are the obligations on providers of relevant services to keep children safe from harm whilst availing of their services, to carry out a risk assessment and to develop a Child Safeguarding Statement, setting out the policies and procedures in place to manage any risk identified.

It is the responsibility of each Government Department, including my own, to ensure that children and young people are kept safe while accessing services provided or funded by them. The Sectoral Implementation Plans produced by each Government Department apply not only to that Department but also to any organisation providing a relevant service to children and receiving funding from that Department in that regard. In this way, these Plans should ensure that public funding is linked to full compliance with the requirements of the Children First Act.

Of course, ever before the commencement of the Act, the Children First National Guidance has been in place since 1999 and was fully revised in 2017 to include reference to the provisions of the Act. The Guidance sets out definitions of abuse, and signs for its recognition. It explains how reports about reasonable concerns of child abuse or neglect should be made by the general public and professionals. It also sets out safeguarding best practice to assist any organisation providing a service to children to create a safe environment.

It is everyone's responsibility to protect children and young people and to do our best to keep them safe. By reaffirming our commitment to child safeguarding and by working together in the interests of children, this can be achieved.

Background

The Department of Children, Equality, Disability, Integration and Youth deals with policy and service developments relating to a number of very important groups in society. It seeks to co-ordinate and develop key actions across Government relating children and young people. It also works on issues relating to some of our most vulnerable groups including children at risk, children in the care of the State, and other vulnerable, minority and disadvantaged groups. It emphasises inclusivity and support in the area of equality. It is responsible for international protection accommodation for those seeking asylum in Ireland and, in the near future, it will take on responsibility for disability services that are currently under the remit of the Department of Health. The Department also deals with a range of important legacy issues from Ireland's past. Finally we deal with a range of issues that are universal to society, including early learning and care for our children, prevention and early intervention services and support and advice for parents. Most of the Department's funded services fall within the definition of relevant services to children under the Children First Act 2015.

The Department of Children, Equality, Disability, Integration and Youth focuses on harmonising policy issues that affect children in areas such as early childhood care and education, youth justice, child welfare and protection, children and young people's participation, research on children and young people, youth work and cross-cutting initiatives for children. The Department has a budget of €1.879bn in 2021, and a staffing complement of 385, and funds a range of services for children and young people, directly and through NGOs and funded agencies, including Tusla. Most of the Department's funded services fall within the definition of relevant services to children under the Children First Act 2015.

Given the remit of the Department, the safeguarding of children is central to the ethos of the Department. The Department is fully committed to meeting all its statutory obligations in relation to child protection, and is further committed to striving to continuously developing best practice standards in all its activities. However, the Department also recognises the central importance of helping children and young people to meet their full potential, and is committed to balancing proportionate risk to continuing to engage with children.

Requirements of the Children First Act 2015

This Children First Sectoral Implementation Plan has been prepared and published in accordance with the Children First Act 2015. Section 27 of the Children First Act 2015 requires each Minister to prepare and publish a Sectoral Implementation Plan in relation to services to children delivered or funded by the Department. Relevant services in this context are defined in Schedule 1 of the Act. The Sectoral Implementation Plan must contain the following:

- A description of the relevant services provided by or on behalf of the Department;
- An outline of the programme of measures taken, or to be taken, to ensure that the Department and any body funded by the Department, is in compliance with the Children First legislation and guidance [namely, the Children First Act 2015 and Children First: National Guidance for the Protection and Welfare of Children [2017];
- An outline of the measures taken or proposed to be taken to promote, review and report on compliance under the legislation and guidance;
- Monitoring and review procedures in relation to the Sectoral Implementation Plan.

The Sectoral Implementation Plan, in accordance with Section 27(4) of the Act, must be laid before both Houses of the Oireachtas. It will also be available on the Department's website.

The Act provides that each Minister shall review and, if appropriate, revise a sectoral implementation plan at intervals of not greater than 3 years.

Relevant services provided by or on behalf of the Department

The development of the Department's Sectoral Implementation Plan was preceded by an audit of every Unit of the Department. Each unit was tasked with identifying any relevant services for children provided by, or funded by, the Unit. They were also required to set out the measures in place, or proposed to be taken, to ensure that the Department itself, or the funded service or body, were in compliance with the Children First legislation and guidance.

The full set of responses at Unit level is attached at Appendix 1.

In addition, there may on occasion be activities carried out by this Department which are not classed as relevant services under Schedule 1 of the Act, but which involve interactions with children. It is also the case that various units of the Department may, in the course of their work, receive correspondence or other communications giving rise to child protection concerns. In line with best practice, this Department has in place policies, procedures and training to support staff and to ensure that Children First principles are understood and followed.

Overview of compliance arrangements

The range of services provided or funded by the Department stretches from once off funding of small projects, to significant funding of sectors, including Early Years and Youth Affairs, and of Agencies, including Tusla, which has a budget in excess of €850m. Child protection was already a significant feature of engagement in relation to DCEDIY funding, with in many cases, child protection structures and supports in place, including provision of training.

Full commencement of the Children First Act 2015 is now complete, with the provisions relating to mandated reporting and Child Safeguarding Statements having commenced on 11 December 2017. Funded agencies and services are now required, in the context of the normal governance processes, to assure the Department that they have identified and are compliant with, all their legal requirements under the Children First Act.

All Units in the Department integrate the obligations of the Children First legislation into their usual governance and compliance engagement with agencies and services receiving funding from the Department. Child safeguarding in general, and compliance with Children First guidance and legislation in particular, is integrated into compliance processes with all funded agencies and services. This in turn is reflected in the normal business planning and risk management processes within the Department.

DCEDIY Children First Oversight Group

A Children First Oversight Group has been in place in the Department for a number of years. The Group consists of representatives from units of the Department with direct contact with children, or significant funding of children's services, and from the Agencies funded by the Department, namely, Tusla, the Adoption Authority of Ireland, and the Office of the Ombudsman for Children. The focus of the Group was child safeguarding generally, and in particular, supporting the Department and its agencies to prepare for the full commencement of the Children First Act 2015.

The focus of the Group following the full commencement of the Act is to support the Department in promoting, reviewing and reporting on compliance with the Children First legislation and guidance, as required by the Act. The Group also has a role in relation to promoting consistency across the Department in relation to governance and compliance in respect of Children First, and related child protection legislation.

The Oversight Group provides updates as required to the Management Board of the Department. The terms of reference and membership for this group are currently under review.

DCEDIY Child Safeguarding Statement

This Sectoral Implementation Plan has been prepared in conjunction with the Department's Child Safeguarding Statement. Both have been prepared on the basis of a detailed audit at unit level of the relevant services for children provided directly by the Department, and relevant services funded by the Department.

As the Department directly provides services to children in respect of some of its functions, it is required to prepare and publish a Child Safeguarding Statement [CSS] under section 11 of the Children First Act 2015. The CSS includes a risk assessment in respect of certain services provided directly to children and young people by the Department, and sets out the mitigating measures in place to address those risks.

The Department's CSS is available on the Department's website and is on view in the Department's headquarters, as required by the Act.

Monitoring and review of the Sectoral Implementation Plan

This is the second iteration of the Department of Children, Equality, Disability, Integration and Youth Sectoral Implementation Plan, and follows an audit by all units of the Department who have undergone an exercise of explicitly identifying the funding of children's services [as defined in the Children First Act] and setting out the programme of measures to ensure compliance with the Children First legislation and guidance.

The Minister for Children, Equality, Disability, Integration and Youth is required, under section 27(5) of the Children First Act 2015, to review and revise a sectoral implementation plan not later than 3 years from the date of publication. This plan will be reviewed no later than March 2024, unless the Minister determines another period, as provided for in the Act.
