# FS006970 - Dredging at Glengarriff Pier

- With regards to timing of the works, no seasonal constraints were identified in the NIS. The timing is dependent on finalising of required permits. Once dates are confirmed for commencement of the works the local IFI office will be informed with contact details for the site supervisor.
- We note the IFI recommendation for the use of soft-start and ramp-up procedures for the dredging to be undertaken, both on a day-to-day basis and on re-start after any stoppages during the day. This will be included as a requirement in the Works Contract.
- All refuelling of machines and equipment will take place well away from the shoreline. All fuels, lubricants and hydraulic fluids must be kept in secure bunded areas away from the shoreline. Dredging will be undertaken in a manner that reduces the volumes of sedimentation in the water column. - The location and method of disposal along with control measures will be forwarded to the local IFI environmental officers in advance of works.
- The council will inform local angling clubs in advance of the commencing of the dredging works.
