Re: Kinsale Head Plan of Development

- 1. Application for approval of an addendum to Plan of Development in accordance with Sections 13 and 13A of the Petroleum and Other Minerals Development Act 1960, as amended, to decommission certain facilities; and
- 2. Application for consent under Section 5(2) of the Continental Shelf Act 1968, as amended, to alter certain facilities in a designated area

Dear Minister

Pursuant to section 13 of the Petroleum and Other Minerals Development Act 1960 as amended (the "1960 Act"), a petroleum lease was granted in respect of the Kinsale Head gas fields and facilities on 7<sup>th</sup> May 1970 (the "Kinsale Head Petroleum Lease"). Pursuant to the terms of the Petroleum Lease, a Plan of Development for Kinsale Head (the "Kinsale Head Plan of Development") was submitted and agreed with the then Minister in respect of Kinsale Head.

The Kinsale Head gas fields and facilities form part of the greater Kinsale Area gas fields and facilities. PSE Kinsale Energy Limited (Kinsale Energy) is completing the decommissioning of the Kinsale Area gas fields and facilities, which have come to the end of their productive life, having been in production since 1978. The Kinsale Area gas fields and facilities are made up of (1) the Kinsale Head gas fields and facilities and (2) the Seven Heads gas field and facilities. Together, the decommissioning of the entirety of the Kinsale Area gas fields and facilities is collectively referred to as the Kinsale Area Decommissioning Project (KADP). The Kinsale Area gas fields and facilities are located in the Celtic Sea, between approximately 40 and 70km off the County Cork coast and onshore at Inch, Co. Cork.

On 28<sup>th</sup> June 2018 Kinsale Energy submitted an application to the Minister for Communications, Climate Action and the Environment (the "Minister") for an addendum to the Kinsale Head Plan of Development, which was submitted to and agreed with the then Minister under the terms of the Kinsale Head Petroleum Lease under section 13 of the 1960 Act, for the decommissioning of certain facilities (platform topsides, platform and subsea wells and subsea infrastructure) as set out in the Decommissioning Plan – Kinsale Head Petroleum Lease (OPL1) – Consent Application No.1 ("Consent Application No. 1"). Consent Application No. 1 was accompanied by an Environmental Impact Assessment Report (EIAR) and an Appropriate Assessment (AA) Screening Report, which were prepared to assess the environmental impacts of the entirety of the KADP, including the decommissioning of the Inch onshore gas terminal. Following a request for further information from the Minister, and a second request for supplementary information, both of which were formally responded to by Kinsale Energy, Ministerial consent for Consent Application No. 1 was received on 26<sup>th</sup> April 2019.

A subsequent application was submitted on 8th August 2019 in respect of the removal of platform jackets ("Consent Application No. 2"). Consent Application no. 2 was approved on 26<sup>th</sup> February 2020.

The EIAR and the AA Screening Report were updated, by way of Addendum, for Consent Application No. 2.

This application now seeks approval as follows:

# 1. Application for approval of an addendum to Kinsale Head Plan of Development under Section 13 of the 1960 Act

Pursuant to Section 13 of the 1960 Act, PSE Kinsale Energy Limited is hereby applying to the Minister for the Environment, Climate and Communications (the "Minister") for approval for an additional addendum to the Kinsale Head Plan of Development. This addendum is seeking consent for the decommissioning of certain facilities set out in the Decommissioning Plan – Kinsale Head Petroleum Lease (OPL1) – Consent Application No. 3 ("Consent Application No. 3"), a copy of which is enclosed with this application and the scope of which is summarised below.

In accordance with Section 13A of the 1960 Act, this application is accompanied by the EIAR which was submitted with Consent Application No. 1 along with:

- i) an addendum to the EIAR to reflect the additional information provided to the Minister on 14<sup>th</sup> November 2018 during the Consent Application No. 1 process, and additional relevant environmental information which has been published since the preparation of the EIAR ( "EIAR Addendum No 1").
- ii) a further addendum to the EIAR to reflect additional relevant environmental information which has been published since the preparation of the EIAR and EIAR Addendum No 1 ("EIAR Addendum No 2").

In addition, the application is accompanied by the AA Screening Report which was submitted with Consent Application No. 1 along with:

- i) an addendum AA Screening Report to reflect the additional information provided to the Minister on 14<sup>th</sup> November 2018 and 12<sup>th</sup> December 2018 during the Consent Application No. 1 process, and additional relevant environmental information which has been published since the preparation of the AA Screening Report ("AA Screening Report Addendum No. 1").
- ii) a further addendum AA Screening Report to reflect additional relevant environmental information which has been published since the preparation of the AA Screening Report and the AA Screening Report Addendum No. 1 ("AA Screening Report Addendum No. 2").

## 2. Application for Consent under Section 5 of the Continental Shelf Act 1968 (as amended)

Pursuant to Section 5(2) of the Continental Shelf Act 1968, as amended, the consent of the Minister is also sought to alter certain facilities in the area designated pursuant to Article 2 of the Continental Shelf Designated Areas Order 1993 SI 92 of 1993.

#### 3. Scope of Consent Application No. 3

The application covers the decommissioning of certain facilities in the Kinsale Head and Ballycotton gas fields, located within the Kinsale Head Petroleum Lease area in offshore petroleum licensing Blocks 48/20, 48/25, 49/16 and 49/21. The activities covered by the application are:

- To leave in-situ all infield pipelines and umbilicals associated with the Kinsale Head gas fields
- To leave *in-situ* the 24" export pipeline (offshore and onshore section) and to fill the onshore section with grout
- To use engineering materials (Rock Placement) to protect the pipelines and umbilicals in situ

Further details of the facilities to be decommissioned and the proposed work schedule are contained in the enclosed Decommissioning Plan - Kinsale Head Petroleum Lease - Consent Application No.3. Following

discussions with DECC regarding potential future use of the facilities, it was the position of the Department that Consent Application No. 3 should be submitted on the basis that arrangements are not to be made to provide for the future use of the pipelines and umbilicals. Kinsale Energy is proceeding with decommissioning on the basis that none of the pipelines or umbilicals will be re-used.

This application covers only the facilities noted above and detailed in Decommissioning Plan - Kinsale Head Petroleum Lease - Consent Application No.3. Consent Application No. 1 covered the removal of topsides structures, subsea production structures, wellheads, spool pieces, umbilical jumpers and all associated protection materials. Consent Application No. 2 covered the removal of the Kinsale Alpha and Bravo jackets. This application covers the remaining facilities to be decommissioned.

## 4. EIAR and AA Screening Report

The above applications are accompanied by an EIAR, EIAR Addendums, an AA Screening Report and the AA Screening Report Addendums. These documents have been prepared to assess the environmental impacts of the entirety of the KADP, including the decommissioning of the Inch onshore gas terminal.

A public notice will be published in the Irish Examiner on 14 October 2021. Copies of the notice are included with this application.
