

Homeless Quarterly Progress Report Quarter 3 2021

Background

Under arrangements in place between the Department and the housing authorities, performance reports are submitted on a quarterly basis through the regional lead authorities¹. The quarterly performance reports include details of the numbers of individuals exiting homelessness into tenancies and the duration of stay in emergency accommodation².

The Homeless Quarterly Progress Report summarises the data submitted to the Department in respect of Quarter 3 2021. The report also includes details on the number of Housing First tenancies created during the Quarter and the number of tenancies in place at the end of the Quarter 3 2021.

Scale of Homelessness

There were 8,475 individuals accessing emergency accommodation at the end of Quarter 3 2021, an increase of 461 individuals on the position at the end of Quarter 2 and a decrease of 181 individuals (2%) on the 8,656 total recorded at end Quarter 3 2020.

There were 1,005 families accessing emergency accommodation at the end of Quarter 3 2021, an increase of 73 on the position at the end of Quarter 2 2021 and a decrease of 123 families (11%) on the 1,128 total recorded at end Quarter 3 2020. The largest number of families recorded to date was 1,778 in July 2018.

Exits from Homelessness

The quarterly performance reports include details of the numbers of adult individuals exiting homelessness. The figures for exits include both exits from emergency accommodation and

persons who were assessed as homeless but were prevented from having to enter emergency accommodation through the creation of a tenancy.

During Quarter 3, a total of 1,308 adults and their dependants exited homelessness into tenancies, a decrease of 4.6% on the 1,371 exits achieved in Quarter 2. A total of 4,043 exits from homelessness have been achieved in the year to date. This represents an 8% decrease on the 4,401 exits achieved over the corresponding period in 2020.

Family Presentations, Preventions and Exits (Dublin only)

In addition to the performance reports, the Dublin Region Homeless Executive has been providing the Department with enhanced data on family homelessness in the Dublin Region. This includes information on family presentations to homeless services, preventions achieved, new families entering emergency accommodation and families exiting emergency accommodation in the Dublin Region. The data provided shows that in Quarter 3 2021:

- Family presentations in the Dublin region are down 3% on the corresponding period in 2020 (from 407 to 395). In the year to date, family presentations are up 55 (5%) on the corresponding period in 2020 (from 1,164 to 1,219);
- The number of families entering emergency accommodation in the Dublin region in Quarter 3 was up slightly on the corresponding period in 2020 (from 205 to 206). To the end of Quarter 3, the number of families entering emergency accommodation was up by 60 (12%) compared to the same period in 2020 (519 to 579);
- Of the families presenting to homeless services in the Dublin Region in Quarter 3, 47% were prevented from entering emergency accommodation by way of a tenancy having been created. In the year to date, 53% of families presenting to homeless services were prevented from entering emergency accommodation by way of a tenancy having been created;
- A total of 111 families exited emergency accommodation into a tenancy in Quarter 3, a 54% decrease on the 242 family exits achieved in the Dublin region in the corresponding period in 2020. In the year to date, 567 families had exited emergency accommodation into a tenancy, a 39% decrease on the corresponding period in 2020.

Length of Stay in Emergency Accommodation – Dublin Region

The Dublin Region Homeless Executive has been providing the Department with enhanced information on the duration spent in emergency accommodation by families in the Dublin Region. The data includes six monthly bands ranging from less than six months to more than two years and relates to all families in emergency accommodation in the Dublin region at the end of Quarter 3 2021.

Housing First

Housing First provides housing and wrap-around supports to rough sleepers and long-term users of emergency accommodation with complex health needs. The National Implementation Plan for Housing First was published in 2018 and includes targets for each local authority. The Plan has an overall national target of 663 new tenancies, to be delivered by the end of 2021.

A total of 56 Housing First tenancies commenced in Quarter 3 2021. Full national rollout has been achieved, with Housing First now operational in every local authority area in the country. The table below sets out the numbers of Housing First tenancies created in each local authority in Quarter 3 2021.

At the end of Quarter 3, the number of tenancies created under the current National Housing First Implementation Plan was 695. This exceeds the 663 tenancies target set out in the Plan. The successor to the current Plan is due for publication in Quarter 4 2021.
