

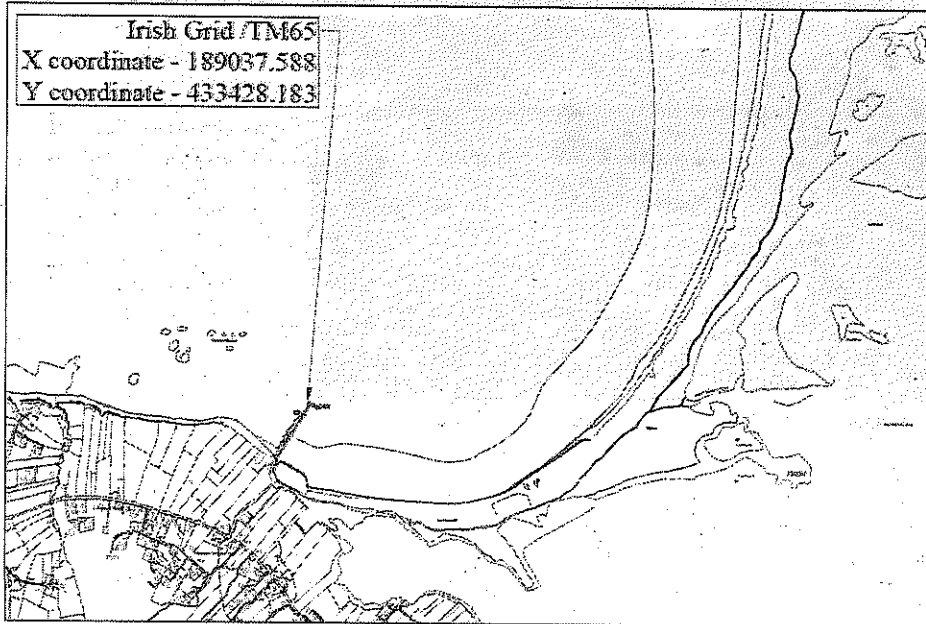

Tugtar fógra, leis seo, de bhun Alt 19 den Acht Imeall Trágha, 1933 go ndearna Comhairle Contae Dhún na nGall iarratas leis an Aire Tithíochta, Rialtais Áitiúil agus Oidhreachta ar cheadúnas Urthrá faoi Alt 3 den Acht thuasluaite chun dreidireacht a dhéanamh ag Céigh Mhachaire Rabhartaigh agus an gaineamh a thagann as sin a spréadh ar Thráigh Mhachaire Rabhartaigh.



An tAire Tithíochta, Rialtais Áitiúil agus Oidhreachta atá freagrach as breith a thabhairt faoin iarratas agus féadann an tAire géilleadh don iarratas, an t-iarratas a cheadú nó toiliú leis an iarratas agus cúnant, coinníoll nó comhaontú á lua, más infheidhme, nó gan cúnant, coinníoll nó comhaontú á lua, nó díúltú don iarratas.

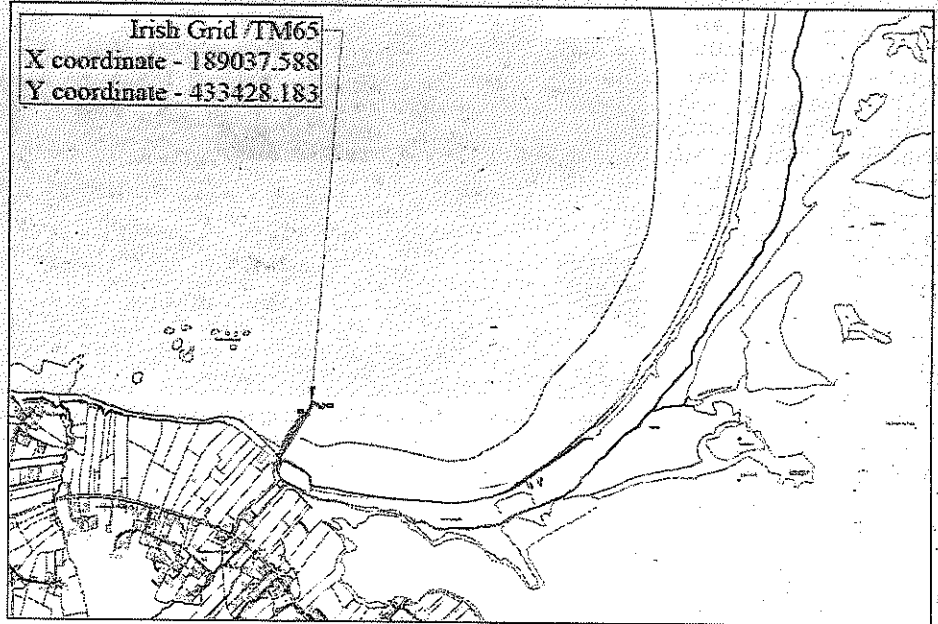

PUBLIC NOTICE

INVITATION FOR PUBLIC SUBMISSIONS OR OBSERVATIONS ON APPROPRIATE ASSESSMENT

Notice is hereby given pursuant to Section 19 of the Foreshore Act, 1933 that Donegal Co. Council has applied to the Minister of Housing, Local Government and Heritage for a Foreshore licence under Section 3 of the said Act for dredging at Magheraroarty pier and disposal of dredged material by means of beach nourishment on Dooley Strand.



The Minister for Housing, Local Government and Heritage is responsible for making a decision on the application and the Minister may either grant, approve or consent to the application with or without covenants, conditions or agreements, where applicable, or refuse the application.

The Minister has determined, in accordance with Regulation 42(6) of the European Communities (Birds and Natural Habitats) Regulations 2011, that an Appropriate Assessment is required in respect of the proposed plan or project. A copy of the Screening for Appropriate Assessment is available on www.housing.gov.ie.

The Minister will make a determination as to whether or not the proposed plan or project would adversely affect the integrity of a European site in accordance with Regulation 42(11) of the European Communities (Birds and Natural Habitats) Regulations 2011 and, in doing so, shall have regard to the matters in Regulation 42(12).

In this regard, in accordance with Regulation 42(13), any person may make a submission or observation to the Minister concerning the proposed project within 30 days of the date of this notice. The Minister shall have regard to any submissions or observations received during the public consultation.

A copy of the application, map of the proposed project, the determination that an Appropriate Assessment is required in respect of the project, the Natura Impact Statement, and the other information and documentation relevant to the application, are available for inspection for 30 calendar days, between **25th November 2021 and 24th December 2021**, free of charge at:
