# Item I - Opening Comments

The Minister welcomed everyone to the sixth meeting of the Committee to oversee the implementation of the National LGBTI+ Inclusion Strategy. He welcomed all Committee members and alternates attending on behalf of members. In noted that in addition to the draft agenda, members received:

The Minister noted that the main focus of committee business would be the **Visible and Included** pillar. There would be briefings from areas with remits under that pillar and from NGOs who have received funding under the LGBTI+ Community Services Programme 2021 to advance work within this remit:

- Sarah Costigan from the Little Museum of Dublin
- Eileen Leahy in the Youth Reform Strategy Unit in this Department
- Zbyszek Zalinski in RTE
- Siobhán Mc Kenna, Head of Equality, Diversity, and Inclusion in the Public Appointments Service and;
- Jonathon McMillan from Enterprise Ireland

In addition to these items, there would be an update on the work of the recently established Sub-Committee on Research.

The Minister stated that he was not in a position to give a commitment in relation to funding.

## Questions

Ailsa Spindler enquired as to why representation on State Boards for LGBTI representatives was set at 20% and suggested that a recommendation be made to the Minister to review this matter. In reply it was noted that there was monitoring in relation to gender which was currently at 50/50.

Gerald Harty (Department of Business Enterprise & Innovation) Stated that there was data collection carried out by PAS involving remote interviews. Had encountered difficulties where English was not the persons first language. In reply it has been considered that there would be links to schools in regards to this data.

Jed Dowling raised a question in relation to data collection in regards to the issue of LGBTI staff being pay less than other staff and whether this issued to be added as part of data collection. In reply it was stated that better data on the issue referred to would be required.

Presentation from Janet Lacey, DCEDIY Chair of the Sub-Committee on Research.

- Confirmed the additional funding for this research had been approved for next year.

Moninne Griffith (BeLonG To Youth Services) raised concerns in relation to gender identity services, in particular the failure to progress cases in the under 17 age group.

The Minister replied that he was aware of the issues of concern in this area. Another issue was highlighted in relation to long waiting lists for treatment.

In reply Joseph Doyle of the HSE;

- Highlighted the HSE difficulties in filling the relevant posts.
- Vacant positions had been advertised, but there was no interest in the positions at this time.
- The HSE will continue looking for options to overcome these recruitment difficulties.
- This is an ongoing process and he HSE was fully engaged in finding a solution.

# International protection System

Paula Fagan (LGBT Ireland) requested an update on IPAS policy.

# Reply:

- Policy is currently being developed as part of reform of International Protection Accommodation Services.
- Vulnerability assessments continue to be carried out, although there continues to be difficulty with this as they may not highlight LGBTI issues.
- Safety and wellbeing of individuals is being promoted.
- Research continues to be carried out and updated policy expected by end of year.

The Minister thanked presenters, departmental agencies and reps, the Secretariat, and everyone for their engagement. Next meeting will take place in early 2022.
