			non-exhaustive list of points in relation to that decision which it is my view that need to be considered.	
			1) The name of someone who is providing specialist technical advice to the Department,	
			presumably in a professional capacity, is not personal information and should not be redacted. In	
			the absence of the name of the person concerned there is no evidence that this information was	
			reviewed by an appropriately qualified and experienced individual. No records are provided as to	
			how or why the particular individual was chosen to review the draft and whether this work was tendered or remunerated.	
			2) No records are provided of any prior correspondence with the individual concerned but the tone	
			of the email supplying the draft for review on 17-12-19 indicates that some prior communication has taken place.	
			3) No records are provided as to how the original draft that was supplied to the unnamed individual	
			arose. Mr XXX XXXX is a Forestry Inspector and not an ecologist, I would therefore have expected	
			to see records involving input from the ecological expertise within the Forest Service to the draft	
			document.	
			4) The wording currently used in AA Determinations differs from that in the documents provided.	
			Records should exist that document the change - e.g. a review of the mitigation or records of a	
			revision to the wording	

			 5) No records have been provided prior to 16-12-2019. Surely there was mitigation in place for Merlin prior to this date. The subject of the email of that date is "Merlin, revised wording". This implies that an original existed that could be revised but this has not been provided. The text of the email refers to a doubling of the exclusion zone from the previous 50m; again clearly indicating that some records prior to the 16-12-19 exist and that an earlier mitigation existed. Records of the development of earlier iterations of the mitigation form part of the development of the current mitigation. 6) The email from XXXX XXXX to XXXX XXXXX on the 16-12-19 concludes with "If you're OK with it, I can see if can review ASAP". There is no record of a response from XXXX XXXXX. The revised wording was sent to ?? for review. There should be a record of Mr XXXXX's comments in response to this email. 7) The mitigation only refers specifically to one SPA (Slieve Aughties) - records should exist that relate to the other SPA's where Merlin is a QI.
