



Grant Levels available under the 2022 EV SPSV Grant Scheme:

1) For **non-wheelchair** accessible vehicles:

For vehicles eligible for EV Scrappage under the Scheme:	
New Battery Electric Vehicle (<3,000kms and <3 months old)	€ 20,000
Battery Electric Vehicle less than one year of age	€ 18,000
Battery Electric Vehicle less than two years of age	€ 16,000
Battery Electric Vehicle less than three years of age	€ 14,000
Battery Electric Vehicle less than four years of age	€ 12,000
For vehicles not eligible for EV Scrappage under the Scheme:	
New Battery Electric Vehicle (<3,000kms and <3 months old)	€ 10,000
Battery Electric Vehicle less than one year of age	€ 9,000
Battery Electric Vehicle less than two years of age	€ 8,000
Battery Electric Vehicle less than three years of age	€ 7,000
Battery Electric Vehicle less than four years of age	€ 6,000



2) For wheelchair-accessible vehicles
