I refer to the above and wish to advise that in the absence of any adverse impact to the safety of navigation, this office raises no objection to this proposed foreshore application.

In addition to the promulgation of a Marine Notice, a notice in a locally read newspaper will be required prior to the commencement of the site investigation works. This notice should provide commencement and completion dates, specific locations, type of activity and any other relevant information.

It is recommended that more detailed consultation with the local fishing community should take place in order to mitigate any risk of collision or damage to equipment.
