## BY-LAWS.

## NETTING IN DUBLIN BAY.

By the Department of Agriculture and Technical Instruction for Ireland.

The Department of Agriculture and Technical Instruction for Ireland by virtue and in exercise of the powers in them vested under the Agriculture and Technical Instruction (Ireland) Act, 1899, and of every other power enabling them in this behalf, DO MAKE AND ORDAIN THE FOLLOWING BY-LAWS:—

1st. It is prohibited to anchor, moor or make fast, for the purpose of, or any purpose accessory to, fishing with a Net known as a Danish Seine (or any Seine or Draft Net by whatsoever name known) hauled by steam or motor power, any boat, buoy, pole or other contrivance in such a manner that it shall be or come within an area bounded by the West Pier at Kingstown, a straight line drawn from the Lighthouse at the seaward end of the said Pier to the Bull Lighthouse, the North Bull Wall and the coast of County Dublin.

2nd. It is prohibited to use any warp or warps exceeding in length four hundred fathoms attached to either wing of any Net hauled by steam or motor power in any part of Dublin Bay within or to the Westward of a limit formed by straight lines (1) from the Bailey Lighthouse to the Easternmost point of the Rocks called the "Mugglins"; (2) thence to the Southern point of Dalkey Island, and (3) thence across Dalkey Sound, in the direction of the Signal Station on Killiney Hill.

3rd. It is prohibited to fish by means of steam or motor power in any part of Dublin Bay within or to the Westward of a limit formed by straight lines (1) from the Bailey Lighthouse to the Easternmost point of the Rocks called the "Mugglins"; (2) thence to the Southern point of Dalkey Island, and (3) thence across Dalkey Sound, in the direction of the Signal Station on Killiney Hill, any Seine or Draft Net, by whatsoever name known, having in any part thereof any mesh less than Two Inches between each knot or Eight Inches in the round, such measurements to be taken in the clear when the Net is wet.

Each and every person offending against any of the foregoing By-Laws shall forfeit and pay for each offence a sum not exceeding FIVE POUNDS, and all Nets used contrary to any of said By-Laws shall be forfeited.
