Project Ireland 2040

This document sets out the regional projects and programmes which are being planned and delivered in the Northern and Western Region as part of the public investment detailed in Project Ireland 2040 - the Government's National Planning Framework and National Development Plan.

While this document does not provide an exhaustive list of all public capital expenditure in the region, it does serve to highlight the diverse range of investment being made by the State under Project Ireland 2040. Project Ireland 2040 set out ten National Strategic Outcomes (NSOs), built around the over-arching themes of well-being, equality and opportunity. This document sets out the main achievements under each NSO in 2021, for the Northern and Western Region.

The document draws on information from a wide range of publicly available sources as well as material provided by Government Departments and Agencies - a list of the major projects in the Northern and Western Region is contained in the Appendix.

The Northern and Western Region covers the administrative areas of 8 counties; Cavan, Donegal, Galway City and County, Leitrim, Mayo, Monaghan, Roscommon and Sligo. The Northern and Western Regional Assembly (NWRA) is part of regional governance in Ireland, established under local government reform in January 2015.

Regional Cities and Centres

Galway City and Metropolitan Area, Sligo and Letterkenny

Project Ireland 2040 seeks to develop our regional towns and cities as viable urban centres of scale, which can act as alternatives and a counterbalance to the continued growth of Dublin and its surrounding region. In doing so, these cities and regional towns will act as drivers of growth for their wider region and rural areas.

Project Ireland 2040 envisages the population of Galway City and Suburbs to grow by between 40,000 - 48,000 people (50-60%) by 2040. In keeping with the vision of compact smart growth, 50% of new city housing will be within the existing Galway City and Suburbs footprint.

Project Ireland 2040 envisages the populations of Sligo and Letterkenny to each grow by approximately 7,700 people (40%) by 2040. In keeping with the vision of compact smart growth, 40% of new town housing will be within the existing Sligo Town and Letterkenny Town footprints.

National Strategic Outcome 1 - Compact Growth

This outcome aims to secure the sustainable growth of more compact urban and rural settlements, supported by jobs, houses, services and amenities, rather than continued sprawl and unplanned, uneconomic growth.

Urban regeneration is reviving Cavan Town Centre, Dublin Street in Monaghan Town, Ballybay, Ballyjamesduff, Clones, Ardee and Carrickmacross Town Centre. There were 613 social housing new builds in the Northern and Western Region in 2021 with more planned in 2022.

There were 2,754 new dwellings completed in the Northern and Western Region in 2021, down 3% on the previous period (2,842).

Urban and Rural Development Fund (URDF)

The Urban Regeneration and Development Fund (URDF) was launched in 2018 to support more compact and sustainable development. The Fund is providing part-funding for applicant-led projects that will enable a greater proportion of residential and mixed-use development to be delivered within the existing built-up footprints of our cities and large towns, while also ensuring that more parts of our urban areas can become attractive and vibrant places in which people choose to live and work, as well as to invest and to visit.

In keeping with the aims of the National Planning Framework and Project Ireland 2040, the URDF demonstrates a new and more tailored approach to the provision of Government support. Over its planned duration up to 2030, URDF support in excess of €2 billion will be targeted in an integrated, dynamic and responsive way to support the regeneration and rejuvenation of our towns and cities.

Through the URDF, successful applicants receive targeted integrated support for innovative holistic solutions to the issues that have hindered the regeneration and rejuvenation of our large towns and cities.

To date there have been two Calls for proposals under the URDF with a total of almost €312 million allocated so far in respect of the 87 projects approved under Call 1, while in March 2021 URDF funding support of €1.3 billion was announced in respect of a countrywide programme of a further 45 proposals approved under Call 2.

The 45 proposals approved under Call 2 in 2021 builds on the existing pipeline of URDF supported projects launched under Call 1. This URDF supported programme of projects will ultimately contribute significantly to the transformative regeneration and development of our large towns and cities, and to the achievement of NPF and Project Ireland 2040 objectives.

National Strategic Outcome 2 - Enhanced Regional Connectivity

A core priority under Project Ireland 2040 is the essential requirement to enhance and upgrade accessibility between urban centres of population and their regions, in parallel with the initiation of compact growth of urban centres.

There are 8 major regional transport project planned for the Northern and Western Region: the N4 Collooney to Castlebaldwin Road; the N56 Dungloe to Glenties Road; the N56 Mountcharles to Inver Road; the Eastern Garavogue Bridge and Approach Road; the Sligo Western Distributor Road; the Galway City Ring Road; the N5 Westport to Turlough Road; and the N5 Ballaghaderreen to Scramoge Road.

 Government approval received to award
 construction contract on 29 January 2019.
 Construction works were completed in October
 2021.
- N56 Dungloe to Glenties Construction ongoing on a phased basis. The N56 Dungloe to Cloghbolie contract was awarded in May 2020 and the N56 Letterlilly to Glenties (Kilraine) was awarded in August 2020.
- N56 Mountcharles to Inver Substantial completion was certified on 19 March 2021.
- Eastern Garavogue Bridge and Approach Road –

Project Ireland 2040 also commits toward an evaluation of the economic benefits and value for money of high-speed rail on the main inter-urban rail network against improvements to existing and planned line speeds along the lines. In 2020, it was decided to expand the scope of this evaluation into an all-island Strategic Rail Review. In consultation with the Department for Infrastructure in Northern Ireland and other relevant stakeholders, terms of reference were agreed and consultants appointed.

The Review commenced in September 2021 and a final report is expected in Quarter 4 of 2022. As well as the potential for high/higher speed rail, the Strategic Rail Review will consider inter-urban and inter-regional connectivity, regional connectivity including to the Northwest, and connectivity to our international air and sea ports, including the potential for rail freight.

National Strategic Outcome 3 – Strengthened Rural Economies and Communities

The Rural Regeneration and Development Fund (RRDF), launched in 2018, is providing the investment needed to support rural renewal, strengthen and build resilience in rural towns, villages and communities and deliver on the objectives of Project Ireland 2040.

The RRDF is administered by the Department of Rural and Community Development (DRCD) and is complemented by a range of additional programmes and schemes delivered under the Department's Rural Regeneration Programme as part of Project Ireland 2040, including the Town and Village Renewal Scheme and Outdoor Recreation Infrastructure Scheme, which help maintain and develop the growth and vitality of rural areas and supports communities and organisations to meet their needs.

13 projects located in the Northern and Western Region were approved for funding of €49,974,734 from the third call for Category 1 applications to the RRDF. 39 projects were approved of funding of €6,235,559 under the Town and Village Renewal Scheme and 91 projects were approved for funding of €6,588,361 under the Outdoor Recreation Infrastructure Scheme. ORIS also funded two nationwide projects. Inland Fisheries Ireland were awarded funding of €491,317 for their Angling Access Maintenance 2022 project and Údarás na Gaeltachta were awarded funding of €500,000 for their Bealach Shéanadh Mhacha / Discover Shéanadh Mhacha project which includes development of a walking/cycling looped trail and nature trails.

Tourism

Project Ireland 2040 recognises the vital contribution tourism makes to the policy goals of strengthening rural economies and communities (NSO 3) and enhancing amenity and heritage (NSO 7). Tourism contributes to essential employment in all counties, especially in regional locations, outside of the main cities where other employment opportunities are limited.

Fáilte Ireland Capital Investment:

Platforms for Growth

Fáilte Ireland is currently investing in large-scale tourism attractions and experiences through its capital investment programme, Platforms for Growth (2019 to 2022). This programme has run two investment platforms to date – a programme of funding to support and expand immersive heritage and cultural attractions and an investment programme, in partnership with Local Authorities, to develop activity facility centres for water-based activities. Both of these platforms completed their assessment processes in 2021 and announced the projects to be supported. Further focused calls on

themed platforms may be announced during the life of the Programme.

Fáilte Ireland's first call for applications (Platforms for Growth 1), in 2019, focused on the platform of immersive heritage and cultural attractions, inviting proposals for large-scale projects of €2.5 million upwards. Through this platform, Fáilte Ireland aims to ensure strong economic growth by investing in heritage and cultural attractions of scale that will motivate visitors to travel, either to and/or within Ireland, but without displacing the existing attractions of a destination or disturbing the competitiveness already in mature destinations. The overall objective is to deliver brilliant experiences that allow visitors connect with Ireland and bring the national and local culture, heritage and people to life, while also delivering greater regional and seasonal spread of tourism. Significant Fáilte Ireland investment totalling over €44 million was announced in June 2021 as part of this first platform to develop four new world-class tourist attractions including:

- Shannon Pot and Cavan Burren Park, Blacklion, Co. Cavan - €4.8 million: This funding will deliver a world-class visitor experience at this UNESCO Global Geopark in the border county of Cavan, in the northern region of Ireland's Hidden Heartlands. The resulting enhanced attraction will include augmented and virtual reality experiences, historical trails, a roof-top viewing platform at the discovery centre, a bridge over the Shannon Pot (source of the River Shannon) and a tree-top walkway at the Cavan Burren Park.
- Fort Dunree and Head, Buncrana, Co. Donegal €9.3 million: This project involves the restoration and enhancement of the entire Dunree Fort and Head area, including the refurbishment of the

- military museum, military huts and former hospital; the installation of glass sky-walks out over the sea; and the development of Ireland's only funicular mountain railway. The resulting world-class visitor experience will showcase the considerable maritime, military, social and political history of this location.
- Westport House Estate and Gardens, Westport, Co Mayo €20.2 million: The proposed restoration, reimagining and re-wilding at Westport House and Garden Estate will offer visitors a multilayered, multi-day experience. A key element is the "Wild Realms" project, which will allow visitors to connect with nature and explore ancient Irish rituals and our ancestors' connections to the land as told through a series of accessible wild and natural spaces. Visitors will also be able to enjoy the enhanced experience of the grand house, with its formal gardens, and learn about the Grace O'Malley family who lived there for centuries.

The second platform (Platforms for Growth 2), launched in December 2020 and involving a targeted call for applications from local authorities, aims to develop activity facility centres at waterside locations across Ireland. In April 2021, €19 million worth of investment was announced for this platform, to be used to develop world-class facility centres at 20 locations across the country where water-based activities are a key visitor attraction. These facilities, designed to serve as a hub in each locality from which multiple water-sports operators can base themselves, will provide hot showers, changing and toilet facilities, secure storage, induction spaces, equipment washdown and orientation points. In the Northern and Western Region, the following facilities were awarded funding:

Of the projects listed above, most are due to open in 2022.

In addition to its large grants schemes and strategic partnerships, Fáilte Ireland also provides capital supports to tourism attractions and experiences in Ireland through a range of regional small grants schemes and makes direct investment into developing infrastructure for the four tourism experience brands including the Wild Atlantic Way which includes counties Donegal, Leitrim, Sligo, Mayo, Galway in the Northern and Western Region and Ireland's Hidden Heartlands which takes in counties Leitrim, Roscommon, Cavan and Galway.

Fáilte Ireland also continues to invest in cultural and heritage tourism attractions through strategic partnerships with the OPW/Department of Housing, Local Government and Heritage; National Parks and Wildlife Service; Coillte; and Waterways Ireland. These critical partnerships continue to deliver capital projects that realise the tourism potential of the State's natural and built heritage assets. Through these strategic partnerships, and other collaborations with Government Departments and agencies, Fáilte Ireland is able to invest in the enhancement of visitor attractions and activities and advise on further experience development and marketing.

Fáilte Ireland has developed an approach to destination development, as set out in its new Destination Development Framework, centred on collaborative local tourism development plans ("DEDPs") that identify agreed priorities for sustainable tourism development of the destination. In 2021 Destination Experience Development Plan launched included Clew Bay Co. Mayo and Lough Derg (comprising part of Counties Tipperary, Clare and Galway).

RRDF-funded projects of tourism significance

In 2021, Fáilte Ireland and Coillte continued to partner on progressing the International Mountain Biking Proposition for Rural Ireland, which received €13.6 million in RRDF funding, administered by DRCD, in 2019. A strategic, large-scale project, it is considered to be of particular importance for developing the activities tourism offering in Ireland

and includes Coolaney Mountain Bike Centre and Trail Development in county Sligo.

Despite periods of lockdown throughout the year, significant progress was made in the development of new trails during 2021. In total, 52km of new trails were completed during the course of the year.

COVID-19

COVID-19 continued to provide challenging circumstances for the tourism industry into 2021 and Fáilte Ireland delivered two investment schemes specifically designed to support the tourism and hospitality sector adapt to the ongoing challenges of the COVID-19 pandemic and a shift in consumer behaviour.

- Under the Outdoor Dining Enhancement Scheme a total of €23 million was awarded to Local Authorities. Strand A of the scheme provided support to almost 5,000 individual independent hospitality and tourism businesses towards the cost of equipment to provide additional outdoor seating and facilitate these individual independent businesses to increase their outdoor dining capacity for summer of 2021. Strand B Grants were awarded to 22 different local authorities for a total of 39 different projects totaling just under €10 million - this funding provides for additional infrastructure and weatherproofing in towns and cities across the country.
- Under the Urban Animation Scheme investment of €4.2 million was awarded to six projects in Cork, Dublin, Galway, Louth, Kilkenny and Waterford to support local authorities in ambitious, creative, innovative and sustainable public realm projects that are inspired by the unique identity of place and integrated into a long-term vision to reimagine and transform the destination.

Cultural Regional Infrastructure

Project Ireland 2040 recognises the value of cultural heritage and sporting facilities as a key component of, and contributor to, the attractiveness and sustainability of our cities, towns, villages and rural areas, in terms of developing cultural creative spaces, quality of life private inward investment, and attracting and retaining talent and enterprise.

A total of €7.1 million was invested in Galway 2020 European City of Culture in 2020 to support the delivery of a revised cultural programme up to April 2021 that took account of changed circumstances due to COVID-19. The development of a legacy framework to sustain and build on the capacity, networks and opportunities arising from cultural programme of Galway 2020 is a key deliverable of the overall European Capital of Culture Action. Over 2021 the Department worked with Galway 2020 and

Galway City and County Councils to develop a legacy framework which will be rolled out in 2022.

A further sum of over €1.6 million was invested in enhancing local arts and cultural infrastructure across the Northern and Western areas in 2021. These included funding of €442,000 paid out as grants under the Arts and Culture Capital Scheme, €1,051,000 under 'Other Cultural Capital' projects, €59,000 under the Regional Museum Exhibition Scheme to seven grantees, and Stream D of the Cultural Capital Scheme 2019-2022, (€71,000). Stream D of the Cultural Capital Scheme 2019-2022 was set up as a response to the COVID-19 pandemic to assist the arts and culture sector. Organisations supported across these various schemes included the Mary Robinson Centre in Ballina, Monaghan County Council in relation to the refurbishment of the Patrick Kavanagh Centre which is due to be officially opened shortly, Macnas CLG and Ballinasloe Town Hall CLG in Galway, Claremorrris Town Hall and Linenhall Arts Centre in Mayo, Cavan County Council re Town Hall Cavan, Hawk's Well Theatre in Sligo, Strokestown House in Roscommon, Cavan and Leitrim Railway Ltd in Leitrim and LATCH CLG in Donegal among others.

€358,000 of the above mentioned funding (under Northern and Western heading) was invested in enhancing local arts and cultural infrastructure across the North East Region in 2021 (Cavan and Monaghan). This included support for projects under schemes such as the Arts and Culture Capital Scheme (€352,000), and the Regional Museum Exhibition Scheme (€5,500).

€68,000 of the above mentioned funding (under Northern and Western heading) was invested in enhancing local arts and cultural infrastructure across the North West Region in 2021 (Sligo and Donegal). This included support for projects under schemes such as the Arts and Culture Capital Scheme (€48,000), and Stream D of the Cultural Capital Scheme (€20,000).

Under the Regional Museum Exhibition Scheme, the Department of Tourism, Culture Arts, Gaeltacht, Sport and Media provided funding to Galway City Museum towards the cost of a large and detailed model of the Claddagh Village and the Jackie Clarke Collection in Mayo towards its Civil War exhibition.

Develop the Creative industries and a vibrant Media Production and Audiovisual sector

Screen Ireland is supporting the establishment of 2 Regional Talent Development Academies (one based in Galway) and 3 Regional Crew Development Hubs (one to be based in Galway) to support skills, talent and workforce development in the regions with a particular focus on equality, diversity and inclusion. The Academies and Hubs will provide access opportunities for new entrants and upskilling opportunities for more established talent and crew. One of the new Crew Hubs will be led by the Atlantic Academy (Danú Media) in Galway. Its activities will also be open to those in other areas covered in the North and Western region, including Clare, Mayo, Roscommon, Sligo, Monaghan, Cavan, Longford, and Donegal.

One of the Talent Development Academies, the Film and TV Drama Academy, will be based in Galway and managed by the Galway Film Centre. The Academy aims to develop and drive opportunities for diverse and regional talent on a national level. This includes ensuring opportunity within the industry for those who may at present feel precluded from a career within the sector.

The skills team in Screen Ireland will continue to address ongoing skills needs in the regions through its courses, funding schemes, through the talent development academies and crew development hubs, and through its work in relation to the skills requirements of the S481 tax credit.

Screen Ireland's Inward Production Unit, both in Ireland and in L.A., promote locations throughout Ireland for filming. They have started a new initiative for the regional film offices to enable them to access, manage and upload locations from their database pertaining to their county.

The Creative Futures Fund was launched as part of Screen Ireland's commitment to grow strong and resilient companies throughout the country. The Fund is designed to help support companies strengthen and hone their expert creative capabilities and ambitions and build cultural resilience to enable high quality cultural projects. 35% of successful companies were based regionally (outside of Dublin and Wicklow).

Screen Ireland launched Building Back Audiences: the Cinema Stimulus Fund, a special initiative to support the exhibition sector in recovering from the severe impact of COVID-19 closures. Eleven cinema venues and a number of cultural cinema networks in the North and Western region benefited from the fund, recognising the immense challenges that Irish independent cinemas face as they reopen their doors and rebuild their businesses.

In 2021, thirteen Screen Ireland funded productions used locations in the North and West of Ireland.

Sustaining Gaeltacht Communities and Promoting the Irish Language

Gaeltacht

In the Donegal Gaeltacht, eleven specific grants totalling over €201,172 were approved in 2021 for various capital projects under the Department's Community and Language Supports Programme to support various Gaeltacht organisations and clubs in carrying out renovation works in addition to purchasing equipment.

An investment of almost €96,000 was approved for Comharchumann Forbartha Ghaoth Dobhair to enable them employ a consultant for the preliminary work relating to the refurbishment of their centre An Crannóg.

286 new jobs were created in the Donegal Gaeltacht during 2021 — the largest number of jobs created in a single year in the county since 2008. At the end of 2021, there were 3,180 full-time jobs in client companies supported by Údarás na Gaeltachta in the Galway Gaeltacht, the highest level ever in the history of the organisation. 337 new jobs were created in client companies in 2021, the county which saw the most employment created for the second year running. 98 new jobs were created in the Mayo Gaeltacht in 2021 — the highest number of job creations in a single year in the county since 2012.

In the Donegal Gaeltacht, a community based renewable energy project, a 5mw photovoltaic project, located on an Údarás na Gaeltachta-owned site on the edge of the Gaoth Dobhair Business Park is being developed as a community-owned project, with ownership shared between six community organisations in the parish of Gaoth Dobhair.

A suite of projects was announced for Lárionad Acmhainní Nádúrtha (LAN CTR in Cill Ulta, Co. Donegal, which could make a significant contribution to the green economy and in terms of global agriculture. Lárionad Acmhainní Nádúrtha CTR, an Údarás na Gaeltachta client in An Fál Carrach, Co. Donegal, is to participate in cutting edge research regarding new farming methods which could change aspects of farming not only in Ireland but worldwide.

In Mayo, Áras Scéalta an Atlantaigh is being developed as a strategic tourism facility, on an international level, on the lorras Peninsula. The project, being led by Údarás na Gaeltachta, is funded through the RRDF, the Department and Údarás. The Hub, at an estimated cost of €2.5 million, will be an orientation point for visitors to learn about cultural and natural heritage points of interest in the area. Funding of €501,000 was allocated by the Department.

Funding of €151,732 has been allocated to Comhar Dhún Chaocháin Teo., in Co Mayo to develop an allweather playground.

In Galway, a comprehensive appeal in respect of the rejected planning application for the overall Páirc na Mara marine innovation park project was submitted to An Bord Pleanála during 2021 and a decision is expected in 2022. Nua na Mara, a marine development and innovation centre was officially established during 2021 with funding support of €2 million from the Regional Enterprise Development Fund.

In 2020, funding of €821,672 was approved for Áras Mhic Amhlaigh, a new Irish language Centre in Knocknacarra, Galway under the Irish Language Support Scheme for Irish Language Centres outside the Gaeltacht. The project has been successfully completed on budget and opened its doors to the public in 2021.

In the Galway Gaeltacht, fifteen specific grants were approved for various capital projects in 2021, including an allocation of €58,425 to Scoil Cholm Cille, Ros a 'Mhíl to enable them employ a consultant for the preliminary works on the construction of a purpose built naíonra.

gteic - Gaeltacht Digital Network

Despite COVID-19 restrictions gteic@GaothDobhair grew and developed during the year due to the completion and availability of the newly-developed second floor. Furthermore, gteic@An Tearmann, gteic@Na Dúnaibh, gteic@Cill Charthaigh and gteic@Árainn Mhór were developed. A further four gteic hubs are expected to open in Donegal in 2021.

Four gteic digital hubs are now open in County Galway, namely gteic@An Cheathrú Rua, gteic@An Spidéal, gteic@Na Forbacha and gteic@Carna. In County Mayo, construction work on gteic@Béal an Mhuirthead, gteic@An Corrán Buí, gteic@Acaill and gteic@An Eachléim has been completed with an investment of €960,000 made to date.

Enhance sport facilities throughout Ireland

The Sports Capital Equipment Programme is the main channel of Government support for developing sports facilities and purchasing sports equipment for sports clubs and organisations across Ireland. The 2020 round of the SCEP closed for applications on Monday 1st March 2021. Over 3,100 applications (the highest ever) were submitted seeking over €200 million. Approximately one thousand of the submitted applications were for 'equipment-only' projects. These applications were assessed first and grants with a total value of €16.6 million were announced on 6th August, 2021. The remaining capital applications were then assessed and 1,865 individual grant offers with a total value of over €143.8 million were announced on Friday 11 February 2022. This represented the highest level of allocation ever made under the SCEP with 1,865 individual grant offers and over 40 different sports funded. All valid applications received a grant offer. Overall, grants of over €36 million were allocated to the Northern and Western region.

The National Broadband Plan

The National Broadband Plan (NBP) is the initiative to rollout high-speed broadband to the 1.1 million people living and working in almost 560,000 premises, including almost 100,000 businesses and farms, along with 679 schools, where commercial operators will not commit to deliver the service. It is expected that eventually over 600,000 premises will be served by the NBP, including new builds.

Broadband Connection Points (BCPs) are public locations which have been selected to receive high-speed connectivity as part of the NBP in areas with poor broadband coverage including many of our offshore islands. By the end of 2021, about 270 BCPs were in place throughout the country and about 250 of these were open for business. These are located in places of community importance including community centres, library hubs, local sports facilities, tourism locations and other public places.

In the Northern and Western region, over 180 BCPs were in place by the end of 2021, 139 of which were open for business and providing high speed broadband services to communities. This includes 85 schools in the Northern and Western region that had a connection installed by the end of 2021 and 51 of these schools were provided with high-speed connectivity. The installation of BCPs and the delivery of public BCPs throughout the country is almost completed. NBI is working to accelerate the rollout of high-speed broadband to schools across the State.

Agriculture Food and the Marine

A key project at Killybegs Fishery Harbour Centre, under the Department of Agriculture Food and the Marine's 2021 Fishery Harbour and Coastal Infrastructure Development Programme, was the continued construction of a 120 metre extension to the pier at Smooth Point to meet the increasing demand from the fishing industry. The pier extension will accommodate vessels with a draft of up to nine metres at low water. A €12.9 million works contract was awarded in August 2019 to deliver the quay extension. €10.4 million has been spent on the project between 2019 and 2021. The contractor experienced difficulties and delays, including those associated with COVID -19 and work ceased on site in August 2021 and the contract was terminated in March 2022. A new contract tender to complete the works was published in April 2022.

National Strategic Outcome 4 - Sustainable Mobility

The expansion of attractive and sustainable public transport alternatives to private based car transport will reduce congestion and emissions and enable the transport sector to cater in an environmentally sustainable way for the demands associated with longer term population and employment growth envisaged under Project Ireland 2040. Furthermore, the provision of safe, alternative, active travel options, such as segregated cycling and walking facilities can also help alleviate congestion and meet climate action objectives by providing viable alternatives and connectivity with existing public transport infrastructure. Continued investment in public transport will be a focus under Project Ireland 2040.

A transport strategy for Galway City was prepared by the National Transport Authority in partnership with Galway City Council and Galway County Council in 2016. The Strategy sets out an overall framework for the development of transport infrastructure and services in Galway City and its environs over a twenty year period.

A review of the Galway Transport Strategy will be undertaken this year and will be led by the National Transport Authority (NTA), in cooperation with Galway City Council and Galway County Council. It will include a comprehensive analysis of changes to population projections, development density, employment forecasts and future travel demand patterns since the finalisation of the current Strategy. This analysis will be utilised to reassess the public transport needs across Galway city and the potential role all modes of transport, including light rail, can play in meeting those needs.

BusConnects

Galway BusConnects will deliver a rationalised network of five high-performing cross city routes. All routes will serve major city centre attractions as well as linking all major destinations across the city, comprise next generation bus lanes, including segregated bike lanes, enhanced services, cashless fares and account-based ticketing. A network of park and ride sites, serviced by the more efficient bus network, will also be put in place. Non-statutory public consultation processes were held in Q4 2020 for two of the five proposed routes - the Dublin Road Scheme and the Cross City Link project. Work has continued on finalising the two schemes and planning permission for the Cross City Link is expected to be sought in Q2 2022. The Dublin Road Scheme will enter the planning process in 2023. In August 2021

An Bord Pleanála gave consent for the development of the Salmon Weir Bridge, a pedestrian and cycling bridge which is an important element of BusConnects Galway. Tender documents issued in December 2021.

Investment in public transport is ongoing within the Region. A best practice example of where the integration of transport, spatial and economic planning is to be delivered is through the Galway Transportation Strategy. This should be used as a template elsewhere and initially as a priority for other areas, including Sligo and Letterkenny, incorporating the cross-border network with Derry.

Letterkenny is targeted as a strategic regional centre and this requires much greater integration of land-use and transport planning which, in turn, enhances the flow and movement of existing and future activities and assets across the wider Northwest City Region. Project Ireland 2040 will enhance connectivity of people and places by promoting sustainable transport options and integrating land use and transport.

TFI Local Link (Rural Transport Programme) provides quality community-based public transport across rural Ireland. Local Link provides both demand-responsive, door-to-door services on request, as well as scheduled bus services on fixed routes.

Greenways

Further funding was granted to support the development of Greenways in the Region with projects supported by the carbon tax fund for pre planning with other projects reaching completion.

Significant works took place on the Dublin to Galway Greenway in 2021. The 106 km, Maynooth to Athlone Section of the Dublin to Galway is complete and fully open. The Greenway follows the towpath of the Royal canal to Mullingar and along the Old Rail Trail between Mullingar and Athlone. The section in Athlone town between Whitelands and the Marina was also opened in August 2021. This section provides a 1km extension to the Old Rail Trail Greenway within Athlone Town.

The Athlone Pedestrian and Cycleway Bridge over the River Shannon is a key component of the urban cycle network necessary to facilitate a safe off-road river crossing connecting the east and west of the country, and critically, connecting the east and west of Athlone town via a dedicated cycle route. The contract was awarded in September of 2021 and the project is currently under construction. The overall length of the main bridge is approximately

104 metres. The proposed section from Athlone to Galway is 140 km in length. Work is ongoing on finalising Emerging Preferred Route design and environmental evaluations.

Other key Projects include:

- Three Greenway projects in Donegal, Buncrana to Carndonagh, Muff to Quigley's Point and from Carrigans to Castlefinn;
- Three Greenway projects in Galway, Clifden to Kylemore Abbey, Clifden to Derrigimlagh and from Athenry to Milltown;
- The Sligo Greenway from Collooney to the Mayo County Boundary;
- The Sligo-Leitrim and Northern Counties
 Greenway managed by Leitrim County Council;
- The Lough Ree Greenway in Roscommon;
- The Mayo Inter-Urban Greenway Westport/ Castlebar/Ballina;
- The Cavan Railway Greenway;
- The Ulster Canal Greenway; and
- Progress also continued in 2020 on construction of the Clifden to Recess Greenway, along with planning and design of extensions to the Great Western Greenway in Achill, and towards Louisburgh and the Galway to Moycullen Greenway.

Active Travel

Project Ireland 2040 commits toward delivery of a comprehensive network of walking and cycling networks in all our major cities and this delivery is supported by a significantly enhanced funding programme.

Active travel projects supported through the design stage and expected to start construction in 2022 include the following:

- Martin Junction Upgrade in County Galway;
- Salmon Weir Pedestrian and Cycle Bridge in Galway City and
- Letterkenny Cathedral One Way and Pedestrian Linkages scheme in County Donegal.

A competitive, innovative and resilient enterprise base is essential to provide the jobs and employment opportunities for people to live and prosper in all regions. Achieving the ambitious employment targets in the National Planning Framework in the context of increased global uncertainty, Brexit, the response to COVID-19 and technological disruption, underlines the importance of building competitive regional clusters and generating an uplift in enterprise export competitiveness to secure sustainable jobs and growth.

The Enterprise Development Agencies continued to support an innovative and resilient enterprise base in 2021.

IDA Ireland

The Northern and Western Assembly Region is made up of the IDA Border and Western Regions. There are 67 IDA client companies in the Border Region, employing 8,721 people and 120 in the West Region, employing 29,419 people. The FDI performance in the region has been strong over the past five years with employment among IDA clients increasing by 22% within the Engineering and Industrial Technologies, Medical Technologies, Technology, International Financial Services and Life Sciences sectors.

The IDA Border region includes the regional growth centres of Letterkenny and Sligo. The region has fostered strong collaboration, for example through Sligo Institute of Technology's participation in National Institute for Bioprocessing Research and Training (NIBRT), the development of the Atlantic MedTech cluster and Letterkenny Institute of Technology's engagement with client companies on the formation of a North-West chapter of Cyber Ireland.

There are 94 IDA supported companies in Galway City and County, employing 22,801 in total. The FDI performance in the Region has been strong over the past five years with employment among IDA clients

increasing by 32%. There is a significant ecosystem of well-established Life Sciences companies, which has helped drive strong cluster development. The number of people employed in software engineering, technical support, global business services and R&D in the Region has also grown considerably.



IDA will continue to work closely with the private sector in the North and West to secure the provision of appropriate and cost-effective building and property solutions for client companies.

Grant Payments to IDA clients in the Region over the last 5 years

Grants paid in a particular year are not necessarily linked to either the investments won or the jobs created in that 12-month period. Grants are generally drawn down over the lifetime of a project which is normally over a period of three to five years. Some investments which result in job creation may not be grant aided and some well-established firms may no longer be receiving grant payments.

Enterprise Ireland in the Northern and Western Region

- The Northern and Western Region is home to 660 Enterprise Ireland client companies employing 33,550.
- From 2019-2021, payments of €79.2 million were made to companies in this region to assist them to start, scale and grow in international markets.
- El has co-funded, with local enterprise development groups, 175 Community Enterprise Centres across the country, including 58 in the Northern and Western Region.
- EI, in partnership with the Institutes of Technology, has established a nationwide network of 16
 Technology Gateways, which deliver technology solutions for Irish industry close to their market needs and are open to all sizes of companies.
 There are three Technology Gateways under the Atlantic Technological University: WiSAR Wireless Solutions, PEM Precision Engineering and Manufacturing and MET Medical and Engineering Technologies.
- The COVID-19 Enterprise Centres Fund was developed to provide financial support to enterprise centres who have been impacted by COVID-19, providing them with financial support for the implementation of a 6 to 12 month Recovery Plan. 3 for profit and 25 not for profit enterprise centres were approved, totaling €2,358,738 in the Northern and Western Region.
- El supports all sectors with success in Construction, BPO, Fintech, Food and Lifesciences.
- El has funded the establishment of a national network of business innovation centres and specialist bio-incubation facilities across the Higher Education Sector. Galway is currently home to 4 business innovation centres; NUIG Business Innovation Centre, NUI Galway Innovation in Business Centre (IIBC), Galway-Mayo Institute of Technology, Galway and the Innovation in Business Centre (IIBC), Castlebar, Galway-Mayo Institute of Technology.

The North East Region, is served by its Local Enterprise Offices (LEOs) in Cavan and Monaghan, supported 362 businesses in 2021, employing 2,377 jobs.

The North West Region is served by its LEOs in Donegal, Sligo and Leitrim, which supported 602 businesses in 2021, employing 2,786 jobs.

The West Region is served by its LEOs in Galway, Mayo and Roscommon, which supported 654 businesses employing 3,291 jobs.

In 2021, the LEOs operating in the Northern and Western Region supported 1,618 businesses employing 8,454 jobs. There was a decrease of 55 in the number of client businesses in 2021 relative to 2020, with the number of jobs increasing by 294 in the same period.

Regional Enterprise development funding

The Regional Enterprise Development Fund (REDF) and Border Enterprise Development Fund (BEDF) support the development and implementation of collaborative and innovative projects that can sustain and add to employment at county, regional and national level.

These funds which are administered by Enterprise Ireland, have been an effective instrument of policy particularly as a complement to the Department

of Enterprise, Trade and Employment's Regional Enterprise Plans where it has served as an enabler for projects emerging from that regional collaborative process.

The Department of Enterprise, Trade and Employment, through Enterprise Ireland, has approved grants totalling over €117 million to drive regional enterprise development initiatives since 2017, under the REDF and the BEDF. The Northern and Western region have secured €40.2 million under these funds.

Regional Enterprise Transition Scheme

The Regional Enterprise Transition Scheme (RETS) was introduced in 2021 to provide funding to existing regionally based not-for-profit clients of Enterprise Ireland and Údarás na Gaeltachta who have received previous support under the REDF and BEDF. The RETS helps eligible enterprises in sectors and regions negatively affected by COVID-19 as well as a consequence of Brexit. In October 2021, 24 projects in total were recommended for funding with a total grant aid request of €9.3 million.

Under the REDF, BEDF and RETS, to date over €126 million in approved grants have been secured by 77 innovative enterprise projects.

Disruptive Technologies Innovation Fund (DTIF)

The Disruptive Technologies Innovation Fund (DTIF) was established in 2018 as part of the National Development Plan and committed €500 million in funding over the period to 2027 for co-funded collaborative projects involving the enterprise and research sectors. DTIF projects focus on the development and deployment of disruptive technologies to deliver new solutions through investment in the development and implementation of innovative products and services that will alter markets or the way business operates.

Since 2018, DTIF invested €235 million in 72 collaborative disruptive innovation projects with strong commercialisation potential under the first three calls of the Fund. Of these, 18 projects with one or more partners located In the Northern and

Western Region were awarded over €62 million. The projects cover areas such as life sciences, medical devices, ICT, artificial intelligence, manufacturing and environmental sustainability. Details of nine of the projects in the region that were awarded almost €34 million under call 3 are set out in the table 13.

A fourth DTIF call was launched in November 2021.

Science Foundation Ireland Programme Activity

Science Foundation Ireland (SFI) funds research that makes a real difference to our society and economy, now and into the future. The agency funds research in Ireland's Higher Education Institutes (HEIs) - often in partnership with Industry or other national and international research funders. This funding ensures that Ireland has the skills, ideas and technologies required to be a true global knowledge economy and that we are addressing societal challenges.

SFI funding opportunities are open to all HEIs across the country and through an extensive peer review process, funding is awarded based on the available budget. A key goal of SFI's Strategy, Shaping our Future, is to "increase geographical involvement and engagement across the country, including through the SFI Research Centres, and increased collaboration with the new Technological Universities and the Institutes of Technology to ensure that benefits arising from our activities are realised across the entirety of Ireland."

In support of this goal, a new funding programme, SFI Frontiers for Partnerships was launched in April 2021. The SFI Frontiers for Partnership call is open to research proposals led by the Technological University (TU) / Institutes of Technology (IoT) sector with partners from the established University sector.

This investment will not only increase financially supported collaboration between the sectors but importantly will provide leadership opportunities for the TU/IoT sector. The programme is being run in partnership with the Geological Survey of Ireland (GSI) and Sustainable Authority of Ireland (SEAI). 85 eligible applications were received and are currently under review. Award announcements are expected to be make in Q2 2022.

SFI provides funding programme to enable deep industry academic collaboration across the country. The SFI Industry RD&I Fellowship seeks to

support academia-industry interactions to address industry-informed challenges. Awards under this programme are made to academic researchers (at faculty and postdoctoral level) wishing to spend time in industry through the temporary placement of academic researchers with an industry partner. 27 researchers have been funded to undertake projects with companies in areas such as VR, chatbots, biotech, coastal erosion and breast cancer representing investment of €2.1 million to support these collaborations. 5 of the 27 placements awarded will be with companies in the North and Western region. The programme is also supported by IDA and applications for the 2022 competition are now open

SFI Research Centres

Since launching in 2012, the SFI Research Centres have transformed the research ecosystem in Ireland, creating an environment where multi-institutional and multi/inter-disciplinary collaborations are now the norm and where industry (both SMEs and MNCs) can effectively join and collaborate with these academic networks.

The SFI Research Centres are helping to improve the quality of people's lives through healthcare, informing public policy on climate change mitigation and they have been instrumental in the delivery of SFI's Education and Public Engagement strategy, including increasing engagement with underserved and underrepresented communities across Ireland.

SFI Research Centres will play a critical role in helping Ireland recover from and succeed in the face of unprecedented global challenges such as BREXIT, future pandemics and climate change. Such threats also present opportunities to harness Ireland's scientific human capital, to create innovative solutions through research and innovation and to ultimately create a more resilient economy and society.

A key objective of the Centres programme is to support SME competitiveness through R&D collaborations, an objective that is critically important in terms of realising the potential for Centres to positively impact on the rebooting of the Irish economy.

The researchers that SFI supports in the HEIs are collaborating heavily with enterprise in Ireland. In 2021 SFI researchers reported 91 formal collaborations with MNCs and 134 collaborations with SMEs in the Northern and Western Region.

SFI currently supports 16 SFI Research Centres, two of which are hosted at NUI Galway.

 CÚRAM, the SFI Research Centre for Medical Devices, aims to radically improve health outcomes for patients by developing 'smart' medical devices

- and implants. It develops these devices through collaborations with industry partners and hospital groups to enable their rapid translation to clinics.
- INSIGHT, SFI Research Centre for Data Analytics is one of the largest data analytics centres in Europe. It undertakes high-impact research, seeks to derive value from Big Data and provides innovative technology solutions for industry and society by enabling better decision-making. The Centre is formally hosted at NUI Galway with strong coleadership at DCU, UCC and UCD.

The current SFI investment in these Centres through the SFI Research Centres Programme is just over €101 million.

It is important to note that although the Higher Education Institutes with responsibility for these Research Centres are based within the North and Western Region (Galway) their academic and industry partners are located right across Ireland. Equally, HEIs within North and Western Regions that are not hosts of the other SFI Research Centres are academic partners on those Centres.

SFI funds 6 Centres for Research Training (CRTs) that are collectively hosted across a partner network of 10 research bodies. The purpose of the SFI Centres for Research Training is to build on research excellence and to provide cohorts of academically outstanding future research leaders with the skills and knowledge required to address the future challenges of an everchanging work environment.

NUI Galway is host to one such SFI Centre for Research Training - SFI Centre for Research Training in Genomics Data Science funding through investment of €13 million. A key feature of the CRTs is the close collaboration with their industry partners to develop PhD programmes which respond to the needs of industry.

Higher Education

Project Ireland 2040 is bringing significant investment in higher education in the Northern and Western Region.

Eleven major infrastructure projects will be delivered around the country as part of a Public Private Partnership Programme (PPP) for the Higher Education sector under Project Ireland 2040, including a Library, IT and Education building at Letterkenny Institute of Technology (LYIT) and a STEM building at Galway-Mayo Institute of Technology (GMIT). These projects respond directly to skills needs at regional level. Both projects are in Bundle 2 of the Higher Education PPP Programme and went to tender in 2021.

A new phase of the Energy Efficiency and Decarbonisation Pathfinder Programme (co-funded

by the SEAI) was agreed in 2021, with the number of projects increased from eight to sixteen. Under this expanded programme, projects for the Letterkenny Institute of Technology (LYIT) and Galway Mayo Institute of Technology were approved to progress to stage 2a. This is in addition to previous projects approved for LYIT and the National University of Ireland (NUI Galway) under the 2020 Energy Efficiency and Decarbonisation Pathfinder Programme (EEDPP). These projects will test and demonstrate energy retrofit approaches, build scale, and inform key stakeholders.

In addition, a decarbonisation pathways analysis was completed for the higher education sector in 2021.

Refurbishment and upgrade works to the main building on LYIT's Killybegs campus were completed in 2021.

Funding of €6.6 million has been approved under the Higher Education Strategic Infrastructure Fund (HESIF) to co-fund a new four storey extension of a central building on IT Sligo's campus (IT Sligo E01 Project). The project was approved to enter into contract in August 2021. The project commenced on site in September 2021.

IT Sligo also secured funding for upgrades to blocks K and L under the Higher Education Refurbishment and Upgrade Fund in 2019. This capital investment will facilitate the consolidation on campus of the recently established Yeats Academy of Arts, Design and Architecture and form a North Campus Creative Hub. The Block K project continued to progress throughout 2020 and reached substantial completion in November 2020. The Block L project progressed to site in September 2021 and is due to be completed in 2023.

NUI Galway Learning Commons Project is one of five projects approved in principle in 2019 for co-funding under the Higher Education Strategic Infrastructure Fund. The project continued through the design stage in 2021.

Further Education

The NDP provided for the first time a dedicated capital envelope for the FET sector. Expenditure increased from €5.5 million in 2018 to €20.8 million in 2021.

This supported 4 Emergency Health and Safety Works (EHSW) projects, 7 capital projects and 1 site acquisition in the Northern and Western Region, spanning a range of objectives. Targeted support was also provided during 2021 for 15 apprenticeship equipment projects across the four ETBs in the Northern and Western region to support new and modernised apprenticeship syllabi, for off-the-job training in ETB training centres. In addition, a Devolved/Minor works Grant of €1.9 million was split across the four ETBs in the region to provide funding for minor capital projects and equipment renewal.

National Strategic Outcome 6 - High-Quality International Connectivity

As an island, continued investment in our port and airport connections to the UK, the EU and the rest of the world, is integral to underpinning international competitiveness. It is also central to responding to the challenges as well as the opportunities arising from Brexit.

Continued Exchequer support for smaller regional airports to underpin connectivity is provided under the Regional Airports Programme 2021- 2025 including at Donegal Airport. Given its scale of operation, Ireland West Airport Knock plays a greater role in terms of international access. Knock undertook two significant developments in 2021, namely a runway end safety area upgrade and the refurbishment and upgrade of the electrical infrastructure. These works follow a major runway rehabilitation project, which was completed in 2019. In addition, Knock Airport's designation as a Strategic Development Zone will contribute to the long-term development of the airport and the regional economy.

National Strategic Outcome 7 - Enhanced Amenity and Heritage

Project Ireland 2040 recognises the value of cultural heritage and sporting facilities as a key component of, and contributor to, the attractiveness and sustainability of our cities, towns, villages and rural areas, in terms of developing cultural creative spaces, quality of life private inward investment, and attracting and retaining talent and enterprise.

Sport Facilities

The Large Scale Sport Infrastructure Fund (LSSIF) was launched in 2018 to provide support for larger sports projects where the level of exchequer support

is greater than that available under the Sports Capital Expenditure Programme (see details of the SCEP under NSO 3). The Fund initially focused on the requirements and development plans of National Governing Bodies of sport and Local Authorities.

Following a detailed assessment process, provisional and formal allocations of €86.3 million have been announced for 33 successful applicants. A number of projects have commenced, while the majority of the projects are undergoing examination of economic analyses and financial workings or completing legal formalities before commencing on site.

Tourism

Tourism development plays a key role in enhancing amenity and heritage (NSO 7) around the country, in conjunction with its role in strengthening rural economies and communities (NSO 3).

With specific regard to State-owned or managed built and natural heritage sites and amenities, Fáilte Ireland has developed a series of strategic partnerships with key State bodies (OPW and Department of Housing, Local Government and Heritage; NPWS; Coillte; and Waterways Ireland) that own and manage attractions and sites considered to be of vital importance to tourism. Through these partnerships, Fáilte Ireland can assist with the refurbishment and enhancement of key visitor attractions and advise on further experience development and marketing, thereby assisting these bodies to unlock the tourism potential of Ireland's natural and built heritage assets and meet the growing international demand for world-class outdoor tourism experiences.

Fáilte Ireland also has, since 2018, a partnership in place with the Department of Rural and Community Development on the funding of that Department's Outdoor Recreation Infrastructure Scheme. The Outdoor Recreation Infrastructure Scheme provides funding for the development of new outdoor recreational infrastructure or the necessary maintenance, enhancement or promotion of existing outdoor recreational infrastructure in Ireland. The scheme seeks to support those sporting and recreational pursuits based on use of the resources of the countryside that contribute to healthy active lifestyles and the economic and tourism potential of the area for both local communities and tourist visitors alike.

Fáilte Ireland-supported amenity and heritage related projects advanced in 2021

In 2021, despite a second year of COVID-19 restrictions, work continued on the following Fáilte Ireland-funded amenity and heritage projects:

- The Shannon Tourism Masterplan [developed under strategic partnership between Fáilte Ireland and Waterways Ireland and in collaboration with the 10 Local Authorities along the navigation] was launched in March 2021. The Plan sets out an ambitious roadmap with 120 actions to support the Shannon to become an iconic visitor experience for Ireland's Hidden Heartlands.
- Significant progress was made on the Beara Breifne Trail Audit Plan, once the COVID-19 lockdowns ended in May 2021. Work is well underway on the Interpretation, Wayfinding and Branding strategies which will ensure the development of the trail as an internationally motivating long distance walking trail.
- Fáilte Ireland and Coillte progressed the
 International Mountain Biking Proposition for
 Rural Ireland, comprising four separate projects

 due to deliver four national trail centres across
 seven counties and over 300km of trails. This
 is considered to be of particular importance
 in developing the activities tourism offering in
 Ireland. It includes the Coolaney Mountain Bike
 Centre and Trail Development in Sligo which saw
 5km of its 24km trail developed in 2021.

In addition to the above projects, which are all aimed at developing the outdoors/activity offering, Fáilte Ireland also progressed its strategic partnership with the OPW and Department of Housing, Local Government and Heritage. Three further projects were advanced in 2021 and will be completed in 2022 under this partnership including the Céide Fields in Co. Mayo. A further nine projects remain under development with the OPW/DHLGH under the Strategic Partnership.

Outdoor Recreation Infrastructure Scheme (ORIS)

In 2021, the ORIS scheme awarded investment of €3.5 million for 189 small scale projects across the country and €15.5 million to develop 66 outdoor recreation projects and development funding for a further 18 projects. Fáilte Ireland contributed €4 million towards these projects in partnership with DRCD in 2021.

Urban Animation Scheme

Fáilte Ireland's Urban Animation Capital Investment Scheme is a pilot capital grants scheme for Local Authorities. Launched in April 2021, this scheme is aimed at supporting sustainable tourism development through public realm and urban animation projects that have the potential to transform and re-imagine urban centres for visitors and communities. Following a competitive assessment process, €4.2 million in funding was awarded to urban animation projects in six counties, where the local stories, culture and heritage will be brought to life through a variety of large-scale outdoor performance spaces, public art and light installations. Galway City Council received funding of €1,030,834 under this scheme.

Platforms for Growth

Fáilte Ireland is currently investing in large-scale tourism attractions and experiences through its capital investment programme, Platforms for Growth (2019 to 2022). This programme has run two investment platforms to date – a programme of funding to support and expand immersive heritage and cultural attractions and an investment programme, in partnership with Local Authorities, to develop activity facility centres for water-based activities.

Fáilte Ireland's first call for applications (Platforms for Growth 1), in 2019, focused on the platform of immersive heritage and cultural attractions, inviting proposals for large-scale projects of €2.5 million upwards. The aim is to ensure strong economic growth by investing in heritage and cultural attractions of scale that will motivate visitors to travel, either to and/or within Ireland, but without displacing the existing attractions of a destination or disturbing the competitiveness already in mature destinations. The overall objective is to deliver brilliant experiences that allow visitors connect with Ireland and bring the national and local culture, heritage and people to life, while also delivering greater regional and seasonal spread of tourism. Significant Fáilte Ireland investment totalling over €44 million was announced in June 2021 as part of this first platform to develop four new world-class tourist attractions, including the following in the Northern and Western region:

- Co. Cavan: Shannon Pot and Cavan Burren Park, Blacklion;
- Co. Donegal: Fort Dunree and Head, Buncrana and
- Co. Mayo: Westport House Estate and Gardens, Westport.

The second platform (Platforms for Growth 2), launched in December 2020 and involving a targeted call for applications from local authorities, aims to develop activity facility centres at waterside locations across Ireland. In April 2021, €19 million worth of investment was announced for this platform, to be used to develop world-class facility centres at 20 locations across the country where water-based activities are a key visitor attraction. These facilities, designed to serve as a hub in each locality from which multiple water-sports operators can base themselves, will provide hot showers, changing and toilet facilities, secure storage, induction spaces, equipment washdown and orientation points.

National Strategic Outcome 8 - Climate-Resilient Society

Project Ireland 2040 highlights the centrality of this National Strategic Outcome (NSO) to all other elements of spatial policy. The themes highlighted in the NPF focus on the role of spatial policy in influencing where we live, where we work, and how we travel. These are all directly relevant to the pattern of energy use, and in particular, the current level of harmful greenhouse gas emissions to which Ireland is committed to achieving substantial reductions.

Project Ireland 2040 continued to see major investment by the commercial state sector in energy, involving ESB/EirGrid:

- Progress has been made on landowner engagement, surveys and borehole investigations at tower sites.
- The North Connacht project will create a new electricity transmission network in the Northwest and will provide capacity for economic growth and to connect new renewable generation. An underground cable option was selected as the best performing option and a route for the cable has been selected.
- ESB and its joint venture partner Bord na Móna enacted Phase 2 of the Oweninny Windfarm (83 MW) in County Mayo.

Climate Action Regional Offices

Four Climate Action Regional Offices (CAROs) were established in 2018 to facilitate effective climate action at regional and local level. The CAROs are operated by a lead Local Authority in four different regions around the country. Counties Cavan, Leitrim, Monaghan and Roscommon are covered by the Midlands and Eastern Region CARO, which is operated by Kildare County Council. Counties Galway, Mayo, Sligo and Donegal are covered by the Atlantic Seaboard North CARO, which is operated by Mayo County Council.

In 2021, the CAROs played a key role supporting the delivery of actions for the local authority sector in the Climate Action Plan across a number of headings including Governance and Partnership, Adaptation, Mitigation, Communication and Engagement, Training and Educations and Knowledge Development. The Midlands and Eastern Region CARO with support from Tipperary County Council and the Local Authority Services National Training Group also supported delivery of the Local Authority Climate Action Training Programme. This Programme aims to develop capacity within the Local Authority sector to deliver ambitious climate action measures at local level. Under the Programme in 2021, climate action training was delivered online or in person to approx. 9,000 Local Authority staff across all grades.

Flood Relief Schemes

There are 30 flood relief schemes currently ongoing or planned for the Northern and Western Region across the following counties;

National Strategic Outcome 9 – Sustainable Management of Water and other Environmental Resources

Project Ireland 2040 highlights the centrality of our sustainable water resources to the implementation of the NDP to underpin our environmental and economic well-being into the future, against the backdrop of the significant deficits in the capacity and quality reflecting historic underinvestment which is being addressed under the NDP.

Overall, there were currently 7 water and waste water projects in progress and a further 56 projects planned in the Northern and Western Region.

Irish Water has eliminated 60% of the raw sewage nationally. In the North and West, construction started in a number of areas where raw sewage has been entering the environment for decades. These include Kerrykeel, Kilcar, Spiddal and Ahascragh.

Irish Water, working in partnership with Donegal County Council, commenced the construction of a new wastewater treatment plant in Kerrykeel as well as the construction of a new pumping station, pumped wastewater main and outfall pipe. The new wastewater treatment plant and sewerage infrastructure to be constructed as part of this scheme will eliminate the discharge of raw sewage and improve water quality in Brunside River and subsequently Mulroy Bay and protect recreational waters for fishing, kayaking and other water sports.

It will also help in protecting the integrity of the local marine environment and supporting future economic and social development in the area. In Spiddal, construction started in 2021 to stop untreated wastewater being discharged directly into Galway Bay. This practice is unsustainable and threatens the amenity value of the local bathing waters, particularly Trá na mBan and Ceibh an Spidéil. The new Wastewater Treatment Plant will bring benefits to Spiddal in terms of health, integrity of the environment and improved water quality for all. This project will stop the discharge of over 600 wheelie bins of raw sewage into Galway Bay per day.

Since 2014, Irish Water have prioritised investment to improve drinking water quality for residents and businesses across Galway. In 2021, Tuam Regional Water Supply Scheme was completed which provides a safe and secure water supply to over 6,000 local residents and businesses.

In 2021, a significant upgrade and expansion at the Foxes Den Water Treatment Plant, the main treatment facility in Sligo Town, was completed to ensure current and future demand can be achieved.

National Strategic Outcome 10 – Access to Quality Childcare, Education and Health Services

Access to quality primary education, health services and childcare, relative to the scale of a region, city, town, neighbourhood or community is a defining characteristic of attractive, successful and competitive places. Project Ireland 2040 provides significant public investment in education and health infrastructure to meet current infrastructure needs, cater for an estimated population growth of one million and respond to Ireland's changing demographic profile.

There were 39 school building projects delivered under the Large Scale and Additional Accommodation Scheme in the Northern and Western Region in 2021 of which 13 (listed in the table below) were of a value in excess of €1 million:

Health

In 2021, COVID-19 continued to impact the programme of capital works in the health sector. Progress was made on a number of Covid-specific projects but also other projects completed construction such as the relocation of the Sexual Assault Treatment Unit at University Hospital Galway, a roof top extension at Sligo University Hospital, providing four additional isolation rooms; and building

works associated with new fluoroscopy equipment at Portiuncula Hospital, Ballinasloe. As part of the Community Nursing Unit programme, following an upgrade and extension, Dungloe Community Hospital was completed. Also in 2021, the provision of an Ambulance Base at St Joseph's Hospital Stranorlar was completed and the Brothers of Charity facility, Galway was refurbished to meet housing requirements for four people with disabilities transitioning from a congregated setting.
