Executive Summary

Our Rural Future 2021-2025 is the Government's national rural development policy, and provides a blueprint for sustainable development of and investment in rural Ireland over its five-year lifespan.

The policy contains a range of measures for implementation across Government throughout this period – these measures will be achieved through the delivery of actions set out in annual work programmes and monitored through the publication of twice yearly progress reports.

This Second Progress Report covers activity which has taken place in Quarter 1 and Quarter 2 of 2022, and reflects the progress made towards the delivery of actions set out in the 2022 Work Programme.

All progress reports and work programmes are published on the Department of Rural and Community Development's <u>Our Rural Future website</u>.

The Second Progress Report contains updates on 148 of the 318 actions in the 2022 Work Programme, with contributions from 22 departments or agencies.

Of these, 35 actions were of an ongoing nature, of the remaining 113, a total of 82 were completed, with the remaining 31 delayed, a completion percentage of 72%.

This includes the completion of 14 actions that were delayed in 2021 and brought forward for completion in the first half of 2022.

A substantial number of actions have taken place across Government in response to the arrival in Ireland of more than 42,000 people escaping the war in Ukraine. This includes a number of specific measures to support rural areas that have welcomed Ukrainian people into their communities.

Due to the ongoing and evolving nature of the situation, this activity has been grouped under a single measure, and includes additional funding being delivered through the SICAP Programme and for Volunteer Centres, the establishment of Community Response Forums in Local Authorities, and the provision of added rural transport services.

Update: NBI continued to face many challenges due to the high number of cases in late 2021 and into 2022. They are, however, implementing a number of measures to help lessen the impact that these delays have had on the rollout. Such measures include:

- Increasing the rate of pole replacement and duct remediation per month
- Bringing in additional NBI resources
- Earlier procurement of materials used in the build stages
- Bringing in additional subcontractors.

As a result of actions taken by NBI, the project has been building momentum and monthly increases in premises passed are being recorded.

Measure 4

Update: The national Connected Hubs Network, together with the connectedhubs.ie platform, was launched on 31 May 2021. The National Hub Network Working Group initially identified and mapped over 400 remote working hubs throughout the country – this number has since increased to more than 500 (130 of which are BCPs). Some 262 of these have been onboarded to the platform and the remainder will be invited to join. The locations of the onboarded hubs, together with the services and facilities they offer and the map location are available <u>online</u>. The work being undertaken by the WDC includes the development of a dataset for the national network's hub infrastructure, which will be used to inform future decision making.

Update:

The IDG for the National Remote Working Strategy (Making Remote Work) includes representatives from DRCD, WDC, CSO and DETE. Pillar Two of Making Remote Work ('to develop and leverage a remote work infrastructure'') contains five actions. DRCD, supported by WDC lead on (amongst others) action two - to '[e]xtend the mapping and classifications of

hubs- as completed by Western Development Commission on the Atlantic Economic Corridor - across the country to develop national data on hub infrastructure'.

The National Hub Network survey was launched in late February 2021 and to date the WDC have mapped and identified over 400 hubs to join the National Hubs Network (over 260 of which have been onboarded onto the platform with this number increasing on an ongoing basis). Verification of the hubs' details is ongoing and details of hubs are available on the interactive map: https://connectedhubs.ie/nationalhubsmap.html.

WDC has shared the national hub dataset with the CSO who are working on action three of pillar two, to '[m]ap commuter, skills and childcare facilities data to inform future hub development decisions'. In May 2022, the CSO published their output, which provides the average distance from residences to hubs and childcare facilities: Distance to Remote Work Hubs and Childcare Services February 2022 (valid at time of publication). In addition, CSO intends to update the 2019 'Measuring Distance to Everyday Services in Ireland' product (Measuring Distance to Everyday Services in Ireland) with additional data and hub/childcare information once Census 2022 data is available next year.

Measure 5

Establish a comprehensive and integrated national network of 400 Remote Working Hubs throughout the country, with shared back-office services and a central booking platform for users.

Update: Version 2.0.0 (V2) of the Connected Hubs platform was rolled out to the public on 26 June 2022, in tandem with the Connected Hubs Voucher Scheme – Phase 1. The latest version of the Connected Hubs app was rolled out on 19 July 2022.

Measure 6

Invest significantly in remote working facilities to support the retention of skilled people in rural communities and attract mobile talent to rural areas.

Update: The 2022 Connected Hubs Call was launched in February, a €5 million funding stream to further support remote working facilities (including BCPs) throughout the country and to add further capacity to the National Hub Network. Some 81 applicants from across the country were successful in securing funding for their applications under this call enabling the ongoing development of the National Hub Network.

6.5 Launch a targeted incentive to encourage the usage of remote working hubs in rural areas.

Update: The Connected Hubs Voucher Scheme was launched on 27 June 2022 and will give remote workers free use of a hot desk at their local digital hub. At least 10,000 hot desk spaces are provided under the Scheme, which is aimed at both existing hub users, as well as those accessing hub facilities for the first time. The scheme will run over two phases with phase one running from 27 June to 31 August. Phase two will start in September and run into early 2023. All users registered on connectedhubs.ie on 27 June will automatically be credited with three vouchers on their account for the use of a hot-desk in phase one. The number of vouchers and use for additional services will be reviewed for phase two.

6.6 Make funding available to Local Authorities to run innovative marketing campaigns targeted at attracting remote workers and mobile talent under 2022 Town and Village Scheme.

Update: A dedicated marketing measure has been introduced for TVRS 2022 for innovative marketing campaigns targeted at attracting remote workers and mobile talent to counties. LAs may apply for up to €50,000 under the measure to run a marketing campaign. Closing date for applications is 22 July 2022.

Measure 8 Develop national data on the incidence and frequency of remote work, to provide an evidence base for future policy.

8.1 Inclusion of specific question in the 2022 Census of Population on whether persons at work ever work from home. If a respondent indicates that they work from home, then a follow-up question is asked on the number of days usually worked from home. Information will be available at detailed geographic level in 2023.

Update: The 2022 Census of Population was conducted in April 2022. The field operation has concluded and the processing of census forms is underway. Information on persons working from home will be published at a detailed geographic level during 2023

Measure 10

Mandate public sector employers, colleges, and other public bodies to move to 20% home and remote working in 2021, with further annual increases over the lifetime of this policy.

Update: The Blended Working Policy Framework for Civil Service Organisations was published on 31 March 2022. This sets out guidance to all civil service organisations for the development and implementation of individual Blended Working Policies.

Measure 12

Through IDA Ireland, Enterprise Ireland and Údarás na Gaeltachta, promote and enable the uptake of remote working across their client base to support regional job creation.

Update: Enterprise Ireland has supported the development of 78 regional projects nationally, under the Regional Enterprise Development Fund & Border Enterprise Development Fund since 2017. Over 40 of these projects are now completed and have commenced operational delivery. These projects offer a mix of start-up, scaling and remote work spaces in almost every county in Ireland.

El is currently in the process of developing and rolling out a promotional campaign to their client base to outline the project facilities, supports and opportunities available in these projects for their businesses.

The IDA will continue to highlight remote working opportunities across its client base (both existing and new client companies), through the promotion of the availability of Ireland's network of hubs and collaboration with regional stakeholders to drive greater take up of remote working opportunities by IDA Ireland client companies.

Update: The IDA announced its half-year results on 6 July 2022.

- 155 investments won up to the end of Q2 73 of them new name investments
- Associated employment potential of over 18,000 jobs
- Strong regional performance continued with 73 of the 155 investments going to regional locations

Many of the "office" based investments have a remote working model and optionality associated with the jobs announced.

IDA Ireland continues to highlight remote working and flexible spaces as Vehicles for Job Creation and Investment into Regional locations in Ireland. The IDA continues to promote the Connect Hubs and the Community and Enterprise Association of Ireland networks to new and existing clients. IDA is also supportive of training initiatives undertaken by local ETB's and clients on how to operate and manage in remote working environments.

Update: The Trading Online Voucher Scheme continues to be a vital support for businesses across the country with 4,450 applications approved by Local Enterprise Offices in 2021 and a further 942 approvals as of the mid-year point in 2022.

14.2	Provide further funding under the Online Retail Scheme.	Complete

Update: The Online Retail Scheme is targeted at retailers to enhance their online capability and presence to best exploit new opportunities and attract new customers. The latest Call under the Scheme (announced 19 July 2022) saw 216 retailers across all counties approved for funding of €9.29 million. 72% of successful applicant companies are based outside of Dublin.

Since 2018 more than 700 projects from retailers based in Ireland have been approved for €28.3m in funding through the Government's Online Retail Scheme. Successful applicants will receive a grant ranging from €10,000 to a maximum of €64,000.

Measure 15 Develop Local Digital Strategies in each Local Authority area, to maximise the potential of improved rural digital connectivity for businesses and communities.

Update: Support is continuing for those Local Authorities which haven't published their local digital strategies. Further research is required in order to align these strategies with the new National Digital Strategy, Harnessing Digital – The Digital Ireland Framework, which was published in February 2022, along with recent European policy developments.

DRCD will engage with Local Authorities that have yet to publish a digital strategy and those that will need to update their strategies in the coming months.

23.1	Enterprise Ireland will continue to drive job creation in the regions through implementation of the Enterprise Ireland Strategy 2022-2024. The LEOs will continue to promote employment growth across the 31 Local Authorities and are engaged with REDF projects in each of the regions.	Ongoing

Update: In 2021, 68% of new jobs were created outside of Dublin by Enterprise Ireland companies. The positive jobs figures saw increases in employment across all regions in Ireland, with, for example, employment increasing by 9% in the Northwest and by 7% in the Southeast.

Through implementation of the Enterprise Ireland Strategy 2022-2024 over 45,000 new jobs will be created by 2024. Over two-thirds of new jobs created in regions outside of Dublin. Although only six months into the strategy Enterprise Ireland has targeted job creation projects and maximised job retention across all regions of Ireland already, through

engagements made by their regional development executives and development advisors nationally.

The first pillar of the strategy is *Export-focused Irish enterprises delivering growth across all regions,* work is ongoing in Enterprise Ireland to develop a new exporter's interactive scorecard which will enable companies to understand their export readiness. Work is also being finalized on the development of a New Exporter Journey, mapping the stages and key requirements for each stage.

Although concrete data is not available for 2022 yet, evidence from monthly PMI pulse surveys carried out by Enterprise Ireland show that both employment and new export orders have increased each month in 2022 thus far in all regions across the State despite the headwinds of inflationary and supply chain challenges.

Update: The network of 33 Gaeltacht community development organisations has been funded on the basis of an annual action plan, with those action plans aligned to Údarás na Gaeltachta's strategy, focusing on areas such as social enterprise, renewable energy, tourism, digital hubs and language planning.

Promote awareness and the use of remote working hubs and enterprise Measure 25 centres across the country to support remote working and encourage local enterprise start-ups.

Update: The first National Connected Hubs marketing campaign was launched in Q1 2022 and included the launch of a Connected Hubs mobile app.

In Q2 2022, a series of announcements to raise the profile of the National Hub Network and remote working generally were made. These announcements were:

- the results of the CH Call 2022
- the launch of the Connected Hubs Voucher Scheme
- €50K grants for Local Authorities to market their remote work offerings.

A smaller regionally-focused marketing campaign has commenced for the summer months to encourage remote workers to utilise local hubs in tourist locations. A more significant campaign and series of announcements are scheduled for Q3/4 2022.

25.3 Develop collaborative strategies with key stakeholders to promote hubs to diverse markets (SMEs, workers, etc.).

Update: With 262 remote working hubs now onboarded to the connectedhubs.ie platform, the focus has shifted to raising awareness of the network, with the first National Connected Hubs marketing campaign being launched in Q1 2022 – this included the promotion of digital hubs to SMEs and remote workers.

The WDC are currently developing the Connected Hubs corporate offering and also reviewing opportunities to support job creation and work activation through the platform.

Work on a National Hub Network Development Policy will begin in 2022.

Measure 26

Maximise our resources and strengths in the Green Economy to support employment opportunities for rural communities in areas such as renewable energy, sustainable tourism, energy retrofitting, the Bioeconomy and the Circular Economy.

Update: As planned the cross-government bioeconomy policy implementation group have met twice in Q1 and Q2 2022.

Update: The Bioeconomy Forum work programme phase 1 has been delivered on schedule. This included five plenary meetings for the period (July 2021 until June 2022). It also included 26 bilateral meetings with Forum members, three working groups delivering a report each and a site visit to the Farm Zero C climate neutral dairy demonstration farm. The report from the Bioeconomy Forum to the Bioeconomy policy implementation was delivered on schedule in July 2022.

26.9 Launch the national retrofitting scheme to drive demand and grow the home energy upgrade market.

Update: The new National Home Energy Upgrade Scheme was launched in February this year. An Exchequer investment of €8 billion to 2030 for retrofit and clarity on the annual allocations for the years to come, will provide confidence to the sector to grow, due to the resulting large and stable pipeline of work that it will support.

Update:

DHLGH: On 31 March 2022, the Minister, together with the Minister for Rural and Community Development, wrote to the chief executives of the local authorities welcoming the establishment of Community Response Forums in every local authority area to coordinate the community-led response in the provision of assistance and support to those arriving into our communities from Ukraine.

The Community Response Forums ensure effective communication and information sharing in the coordination of public and local community and voluntary actions providing community supports to the new Ukrainian communities. To assist this process, a Community Response Forum Framework, i.e. a national template for arrangements to enable all involved at a local level to work together to support the integration of Ukrainian refugees, was developed by the two Departments with the local government sector. Along with the immediate requirement for basic services to be provided, the support also includes a strong focus on integration, education, health, support for job seekers, childcare, etc. There is ongoing engagement with local development companies under the SICAP programme to support LAs at local level in a similar way to how it operated under Covid e.g. language services, campaigns at local level for specific purposes. Good engagement is also in place with the Volunteers Centres around the country.

In recognition of the numbers arriving and the complexity of managing the situation, on 22 April, the Minister wrote again to Chief Executives of local authorities to request that a Director of Service level staff member be assigned full time, supported by a small team, to coordinate the provision of services and supports locally.

DRCD: On 1 June 2022, an additional €10.5 million in funding was announced to assist the community response to support people arriving from Ukraine. €5 million in funding is being provided to the Local Development Companies through the SICAP Programme, €5 million was allocated to Community Foundation Ireland (CFI) in respect of the 'Ireland for Ukraine' Fund and €500,000 is being used to support Volunteer Centres and to provide supports to volunteers. The funding will strengthen the capacity of those already working across the community and voluntary sector to improve the experience and quality of life of people arriving from Ukraine. As new arrivals begin to settle into community life in Ireland, this funding will help ensure that we continue to look after those most in need.

The Community and Voluntary Sector Ukraine Stakeholder Forum has been meeting regularly to share information and feedback from community organisations that are involved in providing supports and services at a local level, lining in with the Community Response Fora.

An initiative has been put forward to the local authority Community Response Fora to avail of underutilised community transport vehicles and to provide flexible transport services to the Ukrainian community, using the additional funding provided to pay for fuel and related costs and recruiting suitably qualified volunteer drivers.

Some additional funding has been provided to organisations funded under the Community Services Programme (CSP) to assist in providing services to the Ukrainian community (See Measure 30.3).

BCP locations are currently being used as emergency accommodation centres to support Ukrainian refugees arriving into the country. Current sites are:

- The Liam Rodgers Centre, Fingal, Co Dublin
- Ballon Community Centre, Co Carlow
- St Patrick's Accommodation Centre, Co Monaghan
- Meenreagh Hostel, Co Donegal

Persons staying at these centres can avail of the use of the WiFi connectivity while there.

D/Transport: On 21 April 2022 it was announced that emergency public transport services would be provided to Ukrainian refugees placed in rural locations.

A three-pronged approach includes the acceleration of elements of the new Connecting Ireland plan, with certain routes identified by the NTA in their public consultation held in Nov-Dec 2021 being prioritised and accelerated. Additional bus services will also be deployed to cater for those housed away from the existing public transport network. Such measures will provide better access to a range of amenities, employment opportunities and to onward public transport connections to larger centres.

A Community Transport Fund was also established to support occasional social travel requests. This is operated by the TFI Local Link offices to enable Ukrainians to join in the many activities that are available in our towns, in particular, activities focused on youth, integration, culture, and education.

DETE: IDA Ireland has shared an inventory of its suitable land holdings and available buildings to the Department and remains in conversation with DETE re same. The majority of IDA land holdings are active Business and Technology Park settings.

LEOs are actively engaged either individually or through community interaction assisting Ukrainian refugees in exploring roads to start your own business or seeking employment in local communities.

DSP: Since the middle of April, Intreo Employment Services have been arranging employment support events across the country specifically for Ukrainians to gather information on their education and skills and to provide information on vacancies and jobs as well as income and training supports to which they may be entitled. To date, Intreo Employment Services staff have engaged with over 12,000 Ukrainians at these events.

D/Education: The Regional Education And Language Teams (REALT) are co-ordinating the provision of education services for Ukrainian families and their children by assisting in finding school places and supporting schools to meet the needs of these children as they emerge, in particular the area of English language supports.

In addition, school transport officials are liaising with the REALT teams and Bus Éireann to ensure all those who require transport have access. These teams are ensuring that clear, accessible information flows are in place between schools, local education support services and national support structures in relation to arrivals from Ukraine.

Teagasc: Teagasc has responded proactively and demonstrated a strong commitment to and support of government policy relating to the housing of refugees from Ukraine. Teagasc has invested in the infrastructure of its colleges in Ballyhaise, Co. Cavan and Clonakilty, Co. Cork, to bring facilities up to an acceptable standard to cater for up to 100 refugees at present.

DTCAGSM:

<u>Creative Ireland:</u> The Creative Ireland programme supports events which are free of charge for children and young people and which will facilitate the full participation of young Ukrainians in a variety of ways, some of which formed part of the Cruinniú na nÓg programme of activities on 11 June. Young Ukrainians arriving in Ireland are benefiting from free artistic supports and creative activities across the country, including free craft classes, storytelling, drama, art, Lego play groups, doll making lessons and circus workshops. Other events include 'The Shared Music Sessions' with Festival in a Van. These events will be rolled out from September 2022 in 10 counties and go beyond the idea of "performing for" and will be shared sessions. Ukrainian musicians will be invited to take the stage in the Van and perform, either as solo artists, or in sets with Irish musicians.

Sport Ireland: Sport Ireland has written to all funded bodies with details of the Government's request for the use of sports halls and clubhouses for temporary accommodation. Sport Ireland's Ethics Unit is currently developing some Ukrainian-focused safeguarding resources which will be available on the website, fully translated, in the coming weeks. Individual national sporting governing bodies have introduced measures within their sports to welcome Ukrainian Refugees and support their integration into local communities. Examples include:

- The waiving of player, coach and referee license fees for Ukrainian Refugees to participate and officiate in sport;
- Removal of registration deadlines;
- Provision of free training wear and other sports equipment.
