## 1. Welcome and introduction

#### 2. Minutes

Further discussions were held in respect of the public consultation following on from those which took place at the meeting of 3 September 2021.

On foot of feedback at the previous session in respect of this topic, a series of proposed questions drawing from the Commission's Terms of Reference were presented to the Commission for comment and review.

#### 4. Donal De Buitléir - Reflections

The Chair welcomed Dr. Donal De Buitléir, who was invited to speak in respect of his experience as Secretary of the 1982-1985 Commission on Taxation.

The session reflected on the work of the 1982-1985 Commission and the context in which the decisions of that Commission were made.

### 5. High Level Design Principles/ Architecture

The Secretary, Colm O'Reardon, led an initial discussion with regard to a finding a common approach for framing the Commission's work and, in particular, addressing cross-cutting issues i.e. those which cut across several policy themes and aspects of the Terms of Reference. A Secretariat paper "High level design principles" was also circulated to the Commission in advance of the meeting to facilitate discussion.

The presentation and paper set out a number of considerations relevant to the work of the Commission, including historical factors and economic theory as well as challenges and opportunities facing Ireland in the medium term. The paper included an initial proposal for design principles/imperatives that could act as a framework for the work of the Commission in light of these considerations. Feedback on this proposal was sought from the Commission as part of this initial discussion.

Following a full initial discussion by members, the Chair noted this topic would be further discussed at a future session (TBD).
