We note that IFI are happy for the application to go ahead with the condition for the biosecurity procedures outlined to be followed when moving between sites and to notify IFI one week in advance of field work taking place. We will ensure this happens.

Sea Fisheries Protection Agency (SFPA)

We note there are no objections or comments from SFPA.
