Minutes

Item	Minutes
Introduction by Chair	The Chair welcomed all members to the meeting and thanked
	everyone for their time and contribution.
Minutes of last meeting	The minutes of meeting 17 were agreed.
TB Resistance in Bulls	Siobhan Ring (ICBF) gave a presentation on breeding for bTb
	resistance in cattle and this generated a lot of positive discussion.
Disease Trends	The Department gave an update on current Tb disease trends and
	talked about the disturbance of badger habitats and the connection
	to TB breakdowns. On foot of a question from the chair on what he
	considered the most important factor in achieving TB eradication, DB
	said he felt stakeholder engagement and co-operation was crucial.
Communications	The Department gave an update on communications since the last
	IWG meeting. The next Communications Sub-Group meeting will take
	place mid-September and will be focused on Animal Health Law
	testing communications.

Wildlife Update	There will be a heavy focus on planning meetings in the RVOs with the wildlife teams in the coming period. These meetings will discuss the badger protect scheme; a partnership with farmers to deploy cages on their land to capture badgers and vaccinate them. The procurement process is currently ongoing. Recruitment challenges and the current vacancies of the wildlife programme were discussed. The number of badgers captured to date in culling zones is 3,493, down 400 from last year. The number of badgers captured in vaccination zones to date is 4,582, down 20 from last year. It can be difficult to get activity in certain areas. Areas with increased culling can have an impact along with dry weather. The badger activity app is still getting notifications. There will be a re-advertisement of the app in September before the start of the season. There will be an update on the Irish Deer Management Forum at the next IWG meeting.
Risk Mitigation Plans	The Department gave a presentation on Risk Mitigation Plans and the proposed updates to the policy. The group were asked to email
	DAFM with any comments on the proposals.
Any other business	There will be a TB Forum meeting in September or October.
