

#### **SUMMARY**

- > An Exchequer surplus of €7.9 billion was recorded to end-September. This compares to a deficit of €6.2 billion recorded to end-September 2021, an improvement of €14.1 billion (figure 1A). The increase reflects strong growth in tax revenues and a decline in voted current expenditure due to the unwinding of Covid-19 supports.
- > On a 12-month rolling basis, a better indicator of the trend, the Exchequer surplus stands at €6.8 billion (figure 1B).
- > Gross revenue to end-September stood at €75.9 billion, an increase of €8.1 billion or 12 per cent compared to end-September 2021.
- > Tax revenue to end-September stood at €57.9 billion, which was €12 billion or 26.2 per cent ahead of the same period last year. The increase is driven by strong growth in income tax, VAT and in particular, corporation tax.
- > Non-tax revenue and capital resources for the first nine months of the year stood at €6.8 billion, down from €10.5 billion in 2021. Appropriations-in-aid of €11.2 billion brought total other revenue to €18.1 billion.
- > Total expenditure to end-September was €68 billion. Of this, gross voted expenditure stood at €59.2 billion, which was €1.4 billion below the same period in 2021. Non-voted expenditure accounted for €8.8 billion, €4.6 billion below the same period in 2021.



#### **Section 1: Revenue**

Gross Exchequer revenue to end-September stood at €75.9 billion, up €8.1 billion or 12 per cent when compared to the same period last year.

Tax revenues of €8.1 billion were collected in September, up by €1.6 billion (figure 2A) with the bulk of the increase driven by corporation tax, which was ahead of last year by almost €1 billion. Total tax receipts for the year to date now stand at €57.9 billion, which is €12 billion or 26.2 per cent higher than the same period in 2021.

Non-tax revenues and capital resources stood at €6.8 billion to end-September, down from €10.5 billion in the first nine months of 2021. Appropriations-in-aid of €11.2 billion brought total other revenue to €18.1 billion.

#### 1.1: Direct Taxes


### Figure 3: income tax developments

**Income tax** receipts of €2.2 billion were recorded in September, some €0.3 billion, or 15 per cent, ahead of September 2021 (**figure 3A**). On a cumulative basis, receipts stand at €21.4 billion, which is €2.9 billion, or 16 per cent, ahead of the same period in 2021.

**Corporation tax** receipts amounted to €2 billion in September, ahead by almost €1 billion on an annual basis (**figure 4A**). This increase primarily relates to payments made this year on 2021 profits and therefore is not expected to carry forward into 2023 receipts. Corporation tax receipts for the first nine months of the year now stand at €13.8 billion, which is almost €5.8 billion ahead of the same period last year, driven by significant increases in profitability in the multinational sector.

#### 1.2: Indirect Taxes

September is a **VAT**-due month, and accordingly receipts of €3.1 billion were collected, ahead of the same month last year by €0.5 billion or 19 per cent (**figure 5A**). Cumulative VAT receipts stand at €15.3 billion, an increase of €2.8 billion, or almost 23 per cent, on the same period in 2021. As noted previously, there is a significant 'base effect' in the cumulative VAT figures, as the economy was still in 'lockdown' through the early months of 2021, depressing VAT receipts and flattering the comparison.

**Excise duty** receipts of €0.4 billion were collected in September, down by around 10 per cent or €46 million on the same month last year (**figure 6A**). For the year to date, receipts stand at €4 billion, and are slightly down by €87 million or 2 per cent on the same period last year. The relative weakness reflects, in part, Government policy introduced to tackle increases in the cost of living.

#### 1.3: Capital Taxes

**Stamp duty** receipts to end-September stood at €1.3 billion, which was €0.2 billion higher than the same period in 2021, primarily reflecting a once-off payment earlier this year.

**Capital gains tax** receipts to end-September stood at €589 million, up by €256 million compared to end-September 2021. The large year-on-year increase is due, in part, to an artificially low base in 2021 due to a technical factor that reduced receipts last year.

**Capital acquisitions tax** receipts of €222 million to end-September were down slightly, by €8 million, on the same period last year.

#### 1.4: Other Taxes

Motor tax receipts of €713 million were collected to end-September, down on last year by €6 million.

**Customs** receipts of €455 million to end-September were €100 million higher than the same period last year. The increase is attributable, in part, to a base effect arising from reduced trade with the UK seen in the early months of 2021.

#### 1.5: Non-Tax Revenue

**Non-tax revenue** to end-September amounted to just over €2 billion, and is broadly flat on the same period last year (down by just €13 million). Higher Central Bank surplus income received so far this year almost offsets lower NAMA surplus income.

#### 1.6: Capital Receipts

**Capital receipts** to end-September amounted to €4.8 billion, down by €3.7 billion on the same period last year. The decrease is due to a reduction in the repayment of the technical loan to the Social Insurance Fund of €4.8 billion. Capital receipts were also boosted by almost €1 billion from the proceeds arising from the sale of bank shares.





A: receipts, € bn



## Figure 6: excise developments





## **Section 2: Expenditure**

Exchequer expenditure to end-September 2022 totalled €68 billion, consisting of gross voted and non-voted expenditure of €59.2 billion and €8.8 billion respectively.

### 2.1: Gross Voted Expenditure

**Total gross voted expenditure** to end-September amounted to €59.2 billion, which was €1.4 billion or 2.4 per cent below the same period in 2021 and 0.2 per cent or €0.1 billion ahead of profile.

**Gross voted current expenditure** of €54.2 billion to end-September was €2 billion or 3.6 per cent below the same period last year and €0.8 billion, or 1.6 per cent, ahead of profile (**figure 8A**).


**Gross voted capital expenditure** of €5 billion was €0.6 billion or 13.4 per cent ahead of last year, and €0.9 billion or 16 per cent below profile (**figure 8B**).

#### 2.2: Net Voted Expenditure

**Total net voted expenditure** to end-September 2022 amounted to €48 billion, which was €1.3 billion or 2.6 per cent below the same period last year and €0.7 billion, or 1.5 per cent, below profile.

**Net voted current expenditure** of €43.1 billion to end-September was down €1.8 billion, or 4.1 per cent, on an annual basis, and €0.2 billion or 0.5 per cent ahead of profile.

**Net voted capital expenditure** to end-September was €4.9 billion, €0.6 billion or 13 per cent ahead of the same period in 2021, and €1 billion, or 16.2 per cent below profile.




#### 2.3: Non-Voted Expenditure

**Non-voted current expenditure**, excluding debt servicing costs, stood at €2.9 billion to end-September, ahead by €292 million or 11.2 per cent on the same period last year.

**Non-voted capital expenditure** to end-September stood at €2.5 billion, down by €4.8 billion on the same period in 2021. This decrease is due to a reduction in the technical loan to the Social Insurance Fund, which is net neutral overall and simultaneously reflected in capital receipts.

#### 2.4: Debt Servicing Costs

Exchequer **debt servicing** costs to end-September was just over €3.4 billion, down slightly by 1.5 per cent on the same period last year and marginally under expectations. Total debt service expenditure for 2022 was estimated at €3.9 billion in Budget 2023.
