In response to your email have reviewed the Foreshore Application **FS007085** and all the environmental documents associated with it. My comments on and recommendations for this application are as follows:

Independent Environmental Consultant (IEC): The Department engaged **MERC** as an IEC to provide assistance with regard to the statutory and non-statutory environmental assessments of this Foreshore Lease application. The IEC has conducted independent assessments of the information provided by the Applicant, having regard to the Habitats Directive and EIA Directive.

Risk Assessment of Annex IV Species

A review of the applicant's environmental reports provide sufficient relevant information in order for a risk assessment of Annex IV species to be carried out by the IEC. The IEC concluded that it is very unlikely that any Annex IV species will be injured or disturbed as a result of the proposed works. Having considered the application by Irish Water and the IEC's report I agree with and accept this conclusion.

Environmental Impact Assessment Regulations

Having considered the application by **Irish Water** the IEC's concluded that the proposed project does not fall within the classes defined under Annex I or Annex II of the EIA Directive. However the Consent Authority (DHLGH) must complete **an Examination for EIA** as part of their obligations under the EIA Directive [see Appendix 1].


Article 6(3) of Directive (92/43/EEC) (as amended) (Habitats Directive): Following screening of the proposed project, the applicant concluded that a Stage 2 Appropriate Assessment was not required as the project, individually or in combination with other plans or projects, is not likely to have a significant effect on European sites.

Having considered the application by Irish Water and their Report to inform AA Screening I agree with and accept IEC's report and its conclusions.
