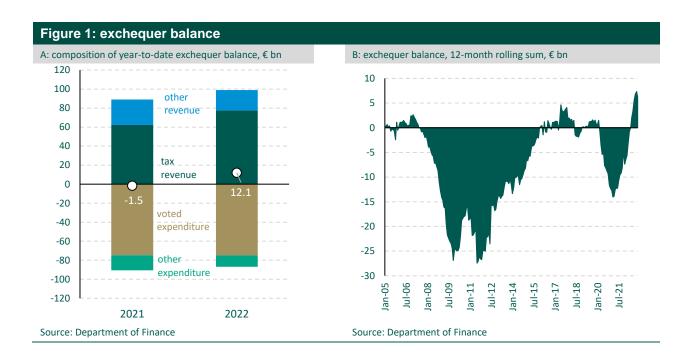

SUMMARY

- > An Exchequer surplus of €12.1 billion was recorded to end-November. This compares to a deficit of €1.5 billion recorded to end-November 2021, an improvement of €13.6 billion (figure 1A). The increase reflects strong growth in tax revenues and a decline in voted current expenditure due to the unwinding of Covid-19 supports.
- > The end-year surplus will be much lower as December is the largest month for expenditure and because the fiscal accounts do not yet fully reflect the Winter Cost of Living package.
- > On a 12-month rolling basis, a better indicator of the trend, the Exchequer surplus stands at €6.2 billion (figure 1B). However, if windfall corporation tax receipts are excluded, this amounts to an underlying deficit of approximately €5 billion on a 12-month rolling basis.
- > Gross revenue to end-November stood at €99.0 billion, an increase of €9.9 billion or 11.1 per cent compared to end-November 2021.
- > Tax revenue to end-November stood at €77.5 billion, which was €15.2 billion or 24½ per cent ahead of the same period last year. The increase is driven by strong growth in income tax, VAT and in particular, corporation tax.
- Non-tax revenue and capital resources for the first eleven months of the year stood at €7.3 billion, down from €12.3 billion in 2021. Appropriations-in-aid of €14.2 billion brought total other revenue to €21.5 billion.
- > Total expenditure to end-November was €86.9 billion. Of this, gross voted expenditure stood at €75 billion, which was €0.2 billion ahead of the same period in 2021. Non-voted expenditure accounted for €11.9 billion, €3.9 billion below the same period in 2021.



Section 1: Revenue

Gross Exchequer revenue to end-November stood at €99 billion, up €9.9 billion or 11.1 per cent when compared to the same period last year.

Tax revenues of €13.6 billion were collected in November, up by €2.2 billion (**figure 2A**). Total tax receipts for the year to date now stand at €77.5 billion, which is €15.2 billion or 24.5 per cent higher than the same period in 2021.

Non-tax revenues and capital resources stood at €7.3 billion to end-November, down from €12.3 billion in the first eleven months of 2021. Appropriations-in-aid of €14.2 billion brought total other revenue to €21.5 billion.

1.1: Direct Taxes

Income tax receipts of €4.4 billion were recorded in November, €0.6 billion, or 16 per cent, ahead of November 2021, reflecting continued increases in earnings as well as the strength of self-employed income (**figure 3A**). On a cumulative basis, receipts stand at €28.3 billion, which is €3.8 billion, or almost 16 per cent, ahead of the same period in 2021, reflecting the continued strength of the labour market.

Corporation tax receipts amounted to €5.0 billion in November, ahead by almost €1 billion on an annual basis (**figure 4A**). Cumulative corporation tax receipts now stand at €21.1 billion, which is €7.6 billion ahead of the same period last year. It has comfortably overtaken VAT to become the State's second largest source of revenue this year. However, as noted previously, some of these receipts are expected to be once-off in nature and will not reoccur next year.

1.2: Indirect Taxes

November is the final VAT-due month of the year, and receipts of €3.1 billion were collected, ahead of last month by €0.5 billion or 19 per cent (figure 5A). Cumulative VAT receipts stand at €18.5 billion, an increase of €3.4 billion, or 22 per cent, on the same period in 2021, reflecting the recovery in consumption.

Excise duty receipts of €0.5 billion were collected in November, down by 30 per cent or €190 million on the same month last year (**figure 6A**). There is a significant 'base effect' in these figures as November last year was a particularly strong month for excise receipts. For the year to date, receipts stand at €5 billion, and are down by €0.3 billion or 5 per cent on the same period last year. The relative weakness reflects, in part, Government policy introduced to tackle increases in the cost of living.

1.3: Capital Taxes

Stamp duty receipts to end-November stood at €1.7 billion, which was €0.4 billion higher than the same period in 2021, primarily due to once-off factors.

Capital gains tax receipts to end-November stood at €848 million, up by €245 million compared to end-November 2021. The large year-on-year increase is due, in part, to an artificially low base in 2021 due to a technical factor that reduced receipts last year.

Capital acquisitions tax receipts of €568 million to end-November were ahead slightly, by €17 million, on the same period last year.

1.4: Other Taxes

Motor tax receipts of €844 million were collected to end-November, broadly flat on last year (down by €2 million).

Customs receipts of €569 million to end-November were €105 million higher than the same period last year. The increase is attributable, in part, to a base effect arising from reduced trade with the UK seen in the early months of 2021.

1.5: Non-Tax Revenue

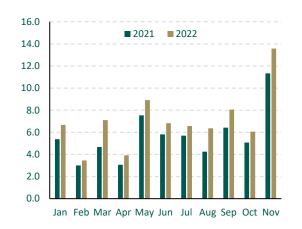
Non-tax revenue to end-November amounted to just over €2.1 billion, and is broadly flat on the same period last year (down by just €67 million). Higher Central Bank surplus income received so far this year broadly offsets the decline in NAMA surplus income.

1.6: Capital Receipts

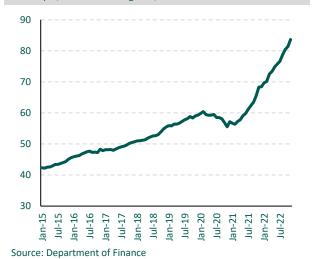
Capital receipts to end-November amounted to €5.2 billion, down by €5.0 billion on the same period last year. The decrease is driven by a reduction in the repayment of the loan to the Social Insurance Fund of €6.2 billion. This technical repayment is net-neutral overall as it is simultaneously reflected in capital expenditure. Capital receipts were also boosted by €1.4 billion from the proceeds arising from the sale of bank shares.

A: receipts, € bn



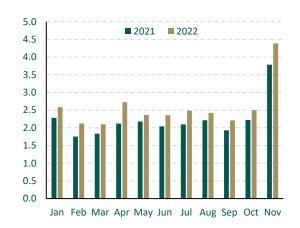
B: receipts, 12 month rolling sum, € bn

A: receipts, € bn



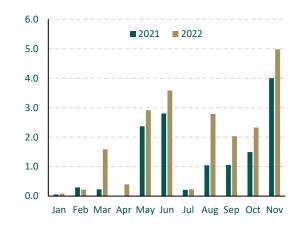
B: receipts, 12 month rolling sum, € bn

B: receipts, 12 month rolling sum, € bn

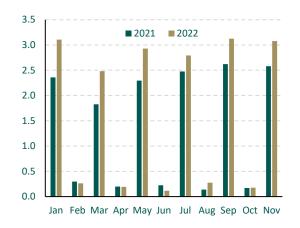

A: receipts, € bn



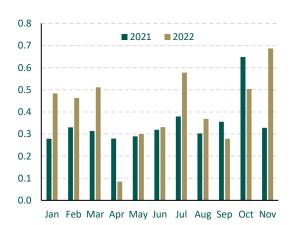
B: receipts, 12 month rolling sum, € bn

Section 2: Expenditure

Exchequer expenditure to end-November 2022 totalled €86.9 billion, consisting of gross voted and non-voted expenditure of €75 billion and €11.9 billion respectively.

2.1: Gross Voted Expenditure

Total gross voted expenditure to end-November amounted to €75 billion, which was €0.2 billion or 0.3 per cent ahead of the same period in 2021 and 1.1 per cent or over €0.8 billion ahead of profile.

Gross voted current expenditure of €68.3 billion to end-November was €0.4 billion or 0.6 per cent below the same period last year and €2.4 billion, or 3.7 per cent, ahead of profile (**figure 8A**).

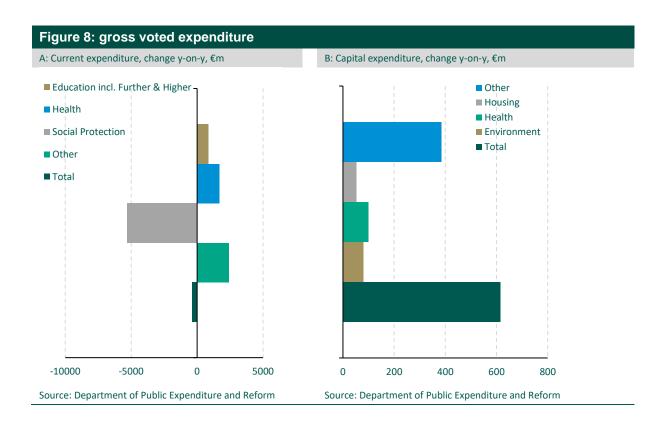
Gross voted capital expenditure of €6.7 billion was €0.6 billion or 10.1 per cent ahead of last year, and €1.6 billion or 19.3 per cent below profile (**figure 8B**).

2.2: Net Voted Expenditure

Total net voted expenditure to end-November 2022 amounted to €60.8 billion, which was over €0.5 billion or 0.9 per cent ahead of the same period last year and €0.2 billion, or 0.3 per cent, below profile.

Net voted current expenditure of €54.1 billion to end-November was down €0.1 billion, or 0.1 per cent, on an annual basis, and €1.4 billion or 2.7 per cent ahead of profile.

Net voted capital expenditure to end-November was €6.7 billion, €0.6 billion or 10.0 per cent ahead of the same period in 2021, and €1.6 billion, or 19.4 per cent below profile.



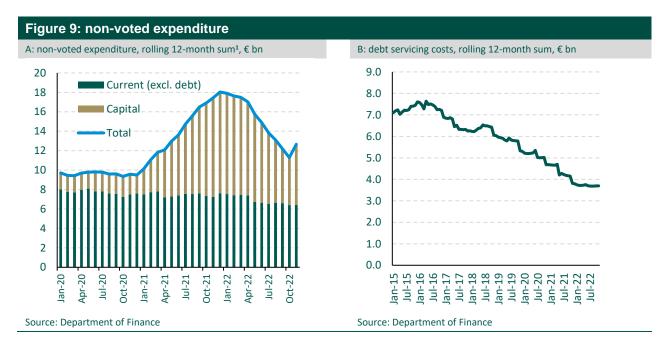
2.3: Non-Voted Expenditure

Non-voted current expenditure, excluding debt servicing costs, stood at €3.5 billion to end-November, ahead by €0.3 billion or 9.4 per cent on the same period last year primarily due to an increase in the EU Budget contribution.

Non-voted capital expenditure to end-November stood at €4.8 billion, down by €4.2 billion on the same period in 2021. This decrease is due to a reduction in the technical loan to the Social Insurance Fund of €6.2 billion, which is net neutral overall and simultaneously reflected in capital receipts. Non-voted capital expenditure to end-November also reflects the transfer of €2 billion to the National Reserve Fund.

2.4: Debt Servicing Costs

Exchequer **debt servicing** costs to end-November was just over €3.6 billion, down slightly by 1.1 per cent on the same period last year and marginally under expectations. Total debt service expenditure for 2022 was estimated at €3.9 billion in *Budget 2023*.
