Re: Forestry Programme 2023 – 2027 Support Scheme Grants and Payments.

Further to the recently announced Grant and Premium rates for afforestation under the new programme, DAFM would like to announce the proposed increase in grant rates for all support schemes and the introduction of Premiums for certain support schemes.

The Forestry Programme Grants and Premiums outlined below are subject to State Aid Approval. Further details on these schemes and implementation dates will be advised by circular shortly.

The maximum metres of fencing funded will be based on the total lengths of new fences erected to Forest Service specifications and based on the area of the forest multiplied by 160 metres, where IS436 is used exclusively, irrespective of fence type erected. Maximum fencing cap of €50,000 per forest. Where non IS436 deer fencing is used a cap of 150 metres per ha will apply to the deer fencing element and capped at €2,100 per ha.

# Intervention 1: Forest Creation – Proposed Environment Report Grant (ERG)

All afforestation projects can now avail of the ERG to help offset additional regulatory requirements in the application process.

#### **Intervention 2 - Creation of Agroforestry Systems**

Three categories of agroforestry will be supported under this intervention:

- 1. Silvopastoral systems (trees and grass).
- 2. Silvoarable systems (trees and crops). (Pilot)
- 3. Forest Gardening (establishment of small-scale food forests). (Pilot)

Grant aid for the establishment Silvopastoral Agroforestry will increase to €8,555 per hectare and the premium for Silvopastoral Agroforestry will increase to €975 per hectare for a period of 10 years.

Parcels of land afforested under Agroforestry will also be entitled to enter the Organic Farming Scheme.

### Intervention 3 - Infrastructure and Technology

Support for forest road construction will increase to €55 per linear metre at a density of 25 metres per ha of served forest and to €10,000 for special construction works along with new additional measures in Intervention 3 – Forest Infrastructure and Technologies.

### Appendix 4

### **Proposed Payment for Ecosystem Services**

Payment for Ecosystem Services (PES) premium pilot has been developed for existing forest owners. This payment is for the management of ecosystem services. Forest owners when receiving approval on certain support schemes may be able to select one (or more) options in accordance with the management practice selected. PES premiums aim to promote the longer-term sustainable management of forests, in particular encouraging forest owners of productive forests to manage their forests with a view to maximising carbon sequestration, water purification and regulation of flow, soil formation, fuel, food and forest genetic resources.
