Fisheries Management Notice No. 65 of 2022

(December Norway Lobster Functional Unit 16 Quota Management Notice)

I, Charlie McConalogue, Minister for Agriculture, Food and the Marine, in exercise of the powers conferred on me by section 12 of the Sea-Fisheries and Maritime Jurisdiction Act 2006 (No. 8 of 2006) and the Sea Fisheries, Foreshore and Dumping at Sea (Transfer of Departmental Administration and Ministerial Functions) Order 2007 (S.I. No. 707 of 2007) (as adapted by the Agriculture, Fisheries and Food (Alteration of Name of Department and Title of Minister) Order 2011 (S.I. No. 455 of 2011)), hereby issue the following Notice:

1. This Notice may be cited as Fisheries Management Notice No. 65 of 2022.
2. This Notice comes into force on 20 :20 hours on 14 December 2022 and ceases to have effect on 01 January 2023.
3. (a) The master of an Irish sea-fishing boat, shall not engage in, or cause or permit any person on board to engage in, fishing activity for Norway Lobster in Functional Unit 16 of ICES Subarea 7 with effect from 20:20 hours on 14 December 2022.

(b) By way of derogation from paragraph 3 (a), an Irish sea-fishing boat may retain onboard and land before 23:59 hours on 14 December 2022, Norway Lobster from Functional Unit 16 of ICES Subarea 7.

This Notice prohibits fishing for Norway Lobster (Nephrops) in Functional Unit 16 of ICES Subarea 7 by Irish sea-fishing boats with effect from 20:20 hours on 14 December 2022, but allows retention on board and landing of Norway Lobster (Nephrops) from Functional Unit 16 of ICES Subarea 7 before 23:59 hours on 14 December 2022
