# Education for Sustainable Development (ESD) Advisory Group for Schools (October 2022)

### **Overarching Structures**

Implementation of ESD to 2030 is co-sponsored by the Department of Education, Department of Further and Higher Education, Research, Innovation and Science (D.FHERIS) and the Department of Children, Equality, Disability, Integration and Youth (D.CEDIY)

- ➤ The three Departments have established an overarching ESD to 2030 Steering Group comprising relevant Government Departments and lead agencies to oversee implementation of ESD to 2030
- ➤ The Department of Education is now establishing an Advisory Group for Schools which will feed into the overarching Steering Group and will liaise with other structures which may be established by D.FHERIS/ D.CDEIY as required.
- Working/ Task Groups will be established to progress specific actions as set out in ESD to 2030.

## **Purpose of the Advisory Group for Schools:**

The ESD Advisory Group for schools will provide a forum for:

- Progressing actions set out in the ESD to 2030 implementation plan 2021 2030 related to the school sector
- Raising awareness about ESD and the SDGs, highlighting existing activity relating to ESD, new developments and resources, and sharing best practice including through input to the ESD Newsletter
- Considering issues arising from the findings of ESD related research;
- Creating opportunities, building partnerships and mobilising stakeholders for ESD
- Contributing to the planning of an annual ESD forum which will invite a wide range of relevant stakeholders to consider issues arising from the work of the Advisory Group;
- Contributing to working/ task groups as required
- Liaising as required with other advisory groups across the education sector
- Reporting on progress to the Steering Group for ESD to 2030 through the Chair

### The Advisory Group for Schools

- The Advisory group for Schools will meet at least quarterly, including the ESD Forum
- The meetings will be facilitated by CAP Unit, Department of Education
- The CAP Unit will provide administrative support to the group
