

Warm-up

- Important to warm-up

- Anyone who has a landline, or can get one, so they can make and receive phone calls, including to the emergency services, please sit down
 - Everyone left standing must be a resident of the Black Valley or an islander !

... which gives us our Problem Statement

- For the residents of, and visitors to, the Black Valley:
- No or poor Broadband
- No or poor mobile coverage (any network)
- No copper no or poor 'landline' service
- What we call the Triple Whammy.
- Impacts magnified during COVID 19



Black Valley phone blackspot putting lives at risk, say residents



"We were told before that the wet weather was to blame for the problems with the phones and now we're told that it's the hot weather that's to blame," he said. "There's a group of 200 people gone visiting the Black Valley today. What if one of them has an accident?"

He said it was "disgraceful" that in the 21st century, huge numbers of householders could be left without a basic service such as a telephone.

"It's like living in another world. They might as well be in Outer Mongolia. The people of the Black Valley have put up with this for too long and their phones must be put right," he said.

Cllr Healy-Rae said that according to Eircom, a new fixed-line service could be installed in the area for approximately ?650,000, which, he said, was "not out of this world" in terms of cost. The existing 'Rurtel' system has failed totally, he added.

He said it was very difficult for people in the tourist industry and those running the local hostel to take bookings at the moment, without a reliable phone

60-second History of Communications in Ireland

- March 7th 1876 Alexander Graham Bell patents the TELEPHONE
- 1921 **P&T** take over the fledgling manually switched network from the Post Office
- 1957 Crossbar automated switches deployed
- 1980+ Digital switches rolled-out
- "This saw a total transformation of the telephone network with modern automatic and digital services reaching even the most rural parts of Ireland by the mid-1980s"
- 1986 Eircell launch Irelands first mobile network
- 1993 Eircell launch GSM (2G) service followed by Digifone
- 2004 Vodafone launch 3G service
- 2013 Meteor launch 4G
- 2020 Three launch 5G

... meanwhile in the Black Valley up to 2022...

- 'Rurtel' radio based System deployed circa 1990
- WiMax based radio system deployed by Eircom circa 2007
- Residents can't make 'landline' calls!
- No Mobile service* 2G, 3G, 4G, 5G
- 50,000 annual visitors to the Black Valley (along the Kerry Way) and the Gap of Dunloe; climbers & hikers on Ireland's highest ridges cant make a mobile phone call

Community Engagement

- Following Representations from local Councillors, Kerry Co.'s Broadband Officer met with the residents to listen to the issues they had.
- With the assistance of DRCD, a Local Telecoms Forum was created in 2021.
- Brought together
 - Community Reps
 - Local Authority mgt
 - Central Govt: DRCD, DECC
 - TelCo's (mobile operators, WISPs, NBI)
- After listening to the scale and impact of the Community's Connectivity problems, TelCo's were invited to brief community on any service improvement plans in the area.

Projects & Initiatives undertaken

- 1. Starlink pilot
- 2. BCP Site
- 3. 'Airband'
- 4. NBI advance engagement
- 5. Eir Mobile new infrastructure and services

Tech billionaire Elon Musk has targeted a remote rural location in Kerry to locate antennae to the stars.

The pilot project, which is shrouded in secrecy, is likely to roll out within weeks in a valley in the MacGillycuddy's Reeks near Killarney.

Musk, founder of SpaceX and electric carmaker Tesla, is deploying showers of satellites into space to provide cheap and fast broadband connections for remote rural locations.

There are strict non-disclosure agreements surrounding the approach by Musk's SpaceX Starlink to Kerry County Council in December.

However, sources have confirmed his small antennae are likely to operate from the remote Black Valley – 20 miles from Killarney.

BCP Site

- The Black Valley National School one of the original 12 BCP sites in Kerry approved by the Minister when the NBP was launched with Community Hubs as an early deliverable
- (Schools were withdrawn by the Patron)
- No other Community Use building in Valley
- Outdoor BCP proposed at the Church with community, parish & DRCD support
- Issues with SMS prevented community deriving value
- That issue fully resolved now so locals and visitors have a drive up 100Mbps+ service.

'Airband'

Microsoft Airband Initiative

We advance access to high-speed internet and meaningful connectivity as a fundamental right.

- With support of Microsoft, DRCD, local and national WISPs and other partners, detailed survey work and field tests were done on the technical feasibility of providing a pilot internet service to over 30 Valley homes and businesses.
- Technically, the results were impressive and the project was feasible, but with the Eir mobile development plan, the project has been parked.

NBI

- The Valley Community have expressed a clear desire to simply "get the same service as everyone else" when it comes to high speed fibre.
- Clearly there are huge topological, technical and amenity preservation impediments to deploying the same class of Fibre network as NBI are rolling out elsewhere in the County.
- Kerry County Council have been engaged with NBI and their Design contractors and the next step is an **Options Report** on the means by which fibre services might be deployed and the screening, technical, operational, maintenance and costs issues with each.



Eir Mobile Developments

- Eir have a U.S.O. with ComReg (Universal Service)
- They have sought to address the issues arising from the existing WiMax system
 - Critical service issues for users
 - License expiry issues
- Proposed to develop services through the rollout of new mobile infrastructure located at the sites of their existing pole assets.
- Voice & Data services for the whole valley
- 999/112 service for all networks
- A game changer for the local community




