## Minutes

Item	Minutes
Introduction by Chair	The Chair welcomed all members to the meeting and thanked
·	everyone for their time and contribution.
Minutes of last meeting	Minutes of the last meeting were agreed. The Chair listed the action points of the last meeting and discussed them briefly. The Farming Organisations asked for examples of the actions to be implemented under the Risk Mitigation Plans and what is involved. The Chair requested the Farm Organisations upload the recently published reactor pack flowchart and FAQs on to their websites.
Whole Genome	Professor Stephen Gordon gave a presentation to representatives on
Sequencing	Whole Genome Sequencing. Question and answers followed.
Disease Trends	The Department presented current disease trends and provided an update on Department targets relating to the work of the IWG.  Data were presented on the level of whole genome sequencing carried out by the CVRL and this work was commended by the chair.

	A report on PVP inspections was also presented. A training course for new VI's is being held in October. A deer management strategy group has been established, following the appointment of a Chair by the Minister. A preliminary meeting is scheduled for September 16 <sup>th</sup> . Notification of restrictions to high-risk herds entering post derestriction check test cycle was discussed.
Chronic herds policy update	The Department presented and update on chronic herds. The IWG agreed to the proposed change in the definition of a relapsed herd to include herds with 3 or more reactors (skin or Gif) and to include atypical herds.
Wildlife Update	The Department gave an update on the wildlife programme. The Farm Organisations were asked to nominate a County Representative to work with the Department on wildlife. The Department asked the Farm Organisations to consider more local meetings on wildlife.
Communications	The Department gave an update on communications. A set of FAQs are to be developed on the animal health law testing requirements.
Any other business	Philip Breslin, Superintending Veterinary Inspector, will be replaced by David Quinn. Philip was thanked for his contribution and commitment to the eradication of bovine TB and his work on the wildlife programme. His expertise, knowledge and dedication were commended.
