Agri-Climate Rural Environment Scheme (ACRES)

Application to become an approved ACRES Advisor

To FAS Advisor

The Agri-Climate Rural Environment Scheme (ACRES) is an environmentally ambitious agri-environment climate measure which forms part of Ireland's CAP Strategic Plan (CSP) 2023 – 2027. €1.5 billion has been allocated to this flagship agri-environment scheme which is the successor to the Green Low Carbon Agri-environment Scheme (GLAS) which was available under Ireland's Rural Development Programme 2014-2020.

ACRES has been designed to deliver significant long-term environmental improvements through participation by a substantial number of farmers on the most appropriate land, with each making a strong improvement on their farm. This will build on, and complement, achievements under Conditionality and the Eco-Scheme.

Two approaches are being used for ACRES, namely:

- an ACRES General approach offering a range of measures for individual farmers (both targeted and general); and
- a Co-operation Project approach, available to farmers in defined high priority geographical areas, who opt to undertake measures, as well as bespoke farm, landscape and river catchment measures. Farmers participating in this approach will have the assistance of a Local Cooperation Project (CP) Team, who will assist with implementation of the scheme at local level.

ACRES is essentially replacing the Green Low-carbon Agri-environment Scheme (GLAS), incorporating some of the EIPs and building on the learnings arising from EIPs and REAP to achieve increased environmental ambition. A more qualitative approach is being adopted through the introduction of a number of results-based actions in ACRES, thereby encouraging the adoption of results-based actions across the country. In addition, the introduction of a Farm Sustainability Plan (FSP) will help achieve the underlying principle of the new AECM framework of "the right measure in the right place".

One of the core requirements of ACRES is that an approved agricultural advisor must prepare the ACRES application including the FSP on behalf of the applicant to ensure that the most suitable and appropriate actions for the farm are selected and submitted.



Approved advisors will also support participants throughout the contract term regarding the completion of actions in line with specifications and, in the ACRES Co-operation approach, liaise with the CP teams to support farmers selecting environmental investments within the CP areas.

The Department of Agriculture, Food and the Marine ('the Department') is now inviting approved FAS Advisors to apply to be an approved ACRES Advisor. An Application Form for this purpose is attached.

- 8. I accept that failure to give advice, prepare and submit plans and documentation for ACRES, in accordance with the Scheme Terms and Conditions and Specifications, will result in my approval as an ACRES Advisor being revoked as appropriate.
- 9. I accept that the Minister may change the terms and conditions of approval as an ACRES Advisor at any time.
- 10. I accept that a conviction for any criminal offence for a wrongdoing found to be done in relation to and/or for the purposes of:
 - An application or a payment provided for under an Act of an institution of the European Union,
 - Including, but not limited to, an offence under Regulation 3 of S.I. No. 169/2016
 European Communities (Direct Support Schemes) Offences and Control
 Regulations 2016, as may be amended, shall result in the revocation of my
 accreditation/ approval as an ACRES Advisor.

11. I agree that a breach of any of the above conditions shall result in refusal, or revocation of my accreditation/approval as an ACRES Advisor.
