After careful consideration on the Marine Survey Office has no objection on to the above referenced application from a navigational safety perspective.

However the following points shall be of note;

- 1. The Licensee shall, through consultation and agreement with the Department of Transport, Marine Survey Office and Commissioners of Irish Lights, arrange for the publication of a Marine Notice through the Maritime Safety Policy Division. The frequency and promulgation of Navtex and radio broadcast warnings shall be agreed in advance with the Irish Coast Guard for the duration of the license period.
- 2. The marking and lighting of moored instruments shall be carried out in consultation with the Marine Survey Office and Commissioners of Irish Lights. Lighting and marking shall be compliant with International Association of Aids to Navigation (IALA) requirements. Information regarding the position of any markings which create a hazard to navigation shall be promulgated to the mariner via publication of a marine notice and all available means appropriate.
- 3. The Licensee shall ensure all appropriate measures are taken for the duration of any on-site activity to ensure the safety of navigation is maintained. Any hazard to safe navigation shall be easily identifiable to all mariners operating within or in the vicinity of the license area.

The email of the 11<sup>th</sup> of July 2022 refers to this licence application for site investigation works off the coasts of counties Dublin and Wicklow.

The importance of the European Sites in this area has been outlined in my first Prescribed Bodies Report dated 13th May 2022. Among the many ecological highlights are that this area includes Special Protection Areas with populations of bird species that are of national and international importance and that it contains the only Special Area of Conservation in Ireland designated for the Annex I habitat Submarine structures made by leaking gases.

As you will note from my Screening Stage Report Environmental Report of the 28<sup>th</sup> June 2022 I concluded that a Stage 2 Appropriate Assessment was required as the project, individually or in combination with other plans or projects, is likely to have a significant effect on European sites. I also identified the requirement for measures to protect the Annex IV species European Otter which occurs at this site to be included as licence conditions.

As stated in my first Prescribed Bodies Consultation I have no objection to this application subject to a complete environmental assessment. I will provide site specific conditions once the environmental assessment process is complete.
