#### National Dairy Beef Welfare Scheme

The objective of the National Dairy Beef Welfare Scheme is to support decision making on farms through better quality data on herd performance and to increase the economic and environmental efficiency of the beef from the dairy herd, and to facilitate further the integration of the dairy and beef sectors by providing support for farmers who are rearing progeny from the dairy herd.

Please ensure you press the "Submit" button on your application or you will not be accepted into the scheme and cannot be eligible for payment.

**Failure to click on the "Submit" button will mean your application has NOT being submitted.**

Please note once your application is submitted **NO** amendments can be made. Therefore please ensure your application is correct before pressing the submit button.

**The closing date for receipt of a valid application is 23.59 on Tuesday 2nd May 2023.**

#### **Late Applications**

*There is a 25-calendar day period after the 2nd May 2023 closing date for the acceptance of late application. However, deductions to payments at a rate of 1% per day in respect of the National Dairy Beef Welfare Scheme will apply to late applications which are received during this period. See table 8.4 of Terms and Conditions for details. Except in cases of force majeure/exceptional circumstances, applications will not be accepted after this 25-calendar day period has ended.*


