NPHET paper on advising Government in relation to the public health restrictive measures currently in place in certain counties

1. Introduction

In light of the epidemiological situation emerging since the last week in July, the NPHET advised on the 7th August that the Government give consideration to the application of a series of enhanced public health restrictive measures to apply to the counties of Kildare, Laois and Offaly for a period of two weeks, at which point the situation will be reviewed. The Government accepted these recommendations and the measures came into effect from midnight on the 7th August and are due to end on Sunday, 23rd August, subject to review.

Since that decision, the number of cases in that region has remained high and the number of cases in other parts of the country has also increased. This led to NPHET recommending, at its meeting on the 17th August, a number of enhanced public health restrictive measures to apply to the remainder of the country. Government considered this advice on the 18th August and accepted this advice with one exception – it allows weddings to proceed up to a maximum of 50 people. The measures are in place until the 13th September.

The measures recommended in both cases were drawn from the suite of possible public health measures set out in the Orange Phase response of the Framework, agreed by NPHET on the 23 July 2020. For ease of reference, please see attached Table in Appendix 1 which sets out the measures detailed in the Framework that apply to the different phases of the Framework, along with those currently applying in Kildare, Laois and Offaly and across the rest of the country as a result of the Government decision on the 18th August. Appendix 2 sets out the Disease Indicators for the different phases.

2. Current Epidemiological Update

Recent updates provided at meetings of 4^{th} , 6^{th} , 7^{th} , 12^{th} , 17^{th} August refer.

A further update will be provided at the meeting.

3. Measures for Consideration by NPHET

On the basis of the epidemiological situation presented at the meeting, the NPHET will be required to review and consider the situation in Kildare, Laois and Offaly, and make recommendations to Government in relation to the measures that are due to end on the 23rd August.

It is proposed that NPHET considers each county separately and discusses and considers whether to advise Government as follows:

- Not to extend the restrictions. It should be noted that the county will then be subject to the nationwide measures in place until the 13th September.
- Extend the restrictions for a further period.
- Impose further restrictions drawing on the Framework as appropriate.

For ease of reference, the following are the remaining Orange Phase measures from the Framework:

- Measures targeted at restricting movement to "essential purposes"
 - Everyone to work from home except for essential workers and other specified workers
 - Public transport reserved for essential workers and passengers travelling for essential purposes
- Majority of businesses/services to close:
 - All retail to close bar essential outlets food, beverages, pharmacies, fuel providers, financial institutions – full list SI 121
 - All personal services
