The Minister for Agriculture, Food and the Marine had requested that the report be presented to the Working Group prior to submission to the Commission. The report had not been circulated as it is still being prepared for publication. Once that is done it will be circulated to the Working Group.

The EPA then made their presentation during the course of which they responded to several questions and requests for clarification from the Working Group. The EPA presentation included the following topics: What is water quality; EPA Monitoring and reporting; Current conditions of waters; How pressures on water are assessed; Commission's Interim Water Quality Assessment required under Article 12 of the Commission Implementing Decision and the outcome of that assessment.

Following the discussion the Chair thanked the EPA for attending. He reminded the Group that DAFM had committed to preparing a discussion paper on ways to improve water quality for the next meeting of the Group.
