excellent work of communications sub-group and the implementation of the policy on enhanced actions to clear infection from extended breakdowns is continuing.

Gerry Kiely, FWG Chair, provided an update on the work completed to date by their working group. He highlighted the success of all parties reaching agreement on the revised compensation rates that will be applied retrospectively from 1st February 2023. Also, agreement reached on the payment to farmers to a maximum of €70 will be provided to breeding herds in 2023 who need to carry out required necessary additional testing on cows of any age or males over 36 months moved from one breeding herd to another breeding herd.

John Griffin, SWG Chair, presented the prioritisation of topics for the provision of research funding by the Department. Giving an overview of the background, methodology and themes he then discussed the results of the survey. Please see the presentation. The Farming organisations felt with development of PCR technology that this new diagnostic method should be treated as priority as an alternative to culture. The TB Forum Chair acknowledged the work completed by the working groups and thanked them for their effort and acknowledged the continued cooperation between all stakeholders involved in the working groups. Question and answers along with discussion followed.

Proposed new actions to consider for 2023 and beyond

The Department proposed new actions for consideration while Simon More proposed point 4.

- 1. TASAH focus on high-risk herds.
- 2. Work with UCD CVERA to identify TB clusters earlier, and the use of machine learning projects to identify high risk animals (DAU) and herds (DCU).
- 3. Further development of Whole Genome Sequencing as an epidemiological tool Regional approach focusing on low Incidence regions to further reduce TB incidence in these areas.
- 4. TB Forum to examine the 'TB Free programme' model being implemented in New Zealand (S. More proposal)

There was discussion on resources within the wildlife programme.

Any other Business

There was a recent RTE article where data and information were quoted from a deer management report. There was no information given about the report within the article and the Department were asked if they could provide the source of the report. There was an update provided about the re-opening of trade with China and their TB requirements to trade.

Close of meeting

The Chair summarised the meeting and thanked everyone for attending, he noted and acknowledged the successful collaborative model of the TB forum. The next TB forum date will be confirmed in due course.
