Introduction by Chair	The Chair welcomed all members to the meeting and thanked

Minutes of last meeting	Minutes of the last meeting were agreed. The Chair listed and
	discussed the action points from the last meeting.
RVO Presentation (Donegal RVO)	Gaetano Durso, Veterinary Inspector, presented a case study of his work within county Donegal. The Chair acknowledged the dedication and commitment of the work to reduce and manage TB in the county. Questions and answers followed.
Disease Trends	The Department gave an update on current disease trends. Please see presentation.
Communications	The Department presented an update on communications since the last meeting. Please see presentation. The 2022 communications strategy was discussed. The strategy's actions were listed and colour coded to highlight their status. The communications working group (CWG) will develop a plan of action for 2023. Next CWG meeting will

	be held on 22nd March. Outlined for the future were further written articles, plans to develop online training for FAS advisors and the reconvening of the Teagasc/DAFM info group. The importance of communicating the key message of selecting TB resistant bulls was raised. It was suggested that Teagasc could demonstrate fencing off badger setts during farm walks. It was also suggested if private veterinary practitioners could be provided with local maps of badger setts. DAFM suggested this could be a possibility for the 500 approved TASAH visits.
Whole Genome Sequencing Case Study	The Department presented a whole genome sequencing case study. Please see presentation. The challenge is we need to build greater data in respect of TB isolates information especially from Wildlife
	perspective. Questions and answers followed.
