### 1. Agreement of 21 July meeting note.

# 2. Update on proposed Blanchardstown District Heating project

CODEMA gave a short update in relation to the above project.

# 3. Update re. Building Regulations/Waste Heat Primary Energy Factor

An interim default Primary Energy Factor for waste heat, and carbon emissions factor has been agreed by the Group tasked with examining the issue. These will be used in relation to the Tallaght District Heating System (TDHS) and Dublin District Heating Scheme (DDHS) schemes until verifiable data becomes available. Scheme operators will make monthly metered data available to SEAI.

A submission in relation to designating SEAI as the responsible body for verification of District Heating (DH) has been approved by the Minister for the Environment, Climate, and Communications.

The Regulations transposing Article 15.4 of Renewable Energy Directive (RED) II are close to being finalised by the Department of Housing, Local Government, and Heritage. Once the transposition has been completed, and DHLGH has amended the Technical Guidance Documents (TGD) Part L accordingly, SEAI will amend the Dwelling Energy Assessment



Procedure (DEAP) manual.

The Group will continue to meet in order to resolve outstanding issues and relevant new issues should any arise.

#### 4. SEAI update to SG

This item was postponed until the next meeting of the DHSG.

#### 5. Planning Working Group update

The Planning Working Group shared current thinking from the Group and outlined potential topics for inclusion in the planning section of the DHSG Report. In terms of planning for expansion of DH, national policy is seen essential to underpin actions and capacity to deliver is key.

Also highlighted were supports that might be required from the DHSG and other Working Groups (WG) to help shape the planning element of the Report.

DHLGH recently surveyed the local authorities in relation to their policy position on DH. The survey is intended to assist in identifying pilot locations for DH.

A discussion took place around the draft Economic and Consumer Protection Regulation and Standards WG.
