Minutes 4th Meeting

1. Welcome and Minutes of the Previous Meeting

The Chair (Bill Callanan) opened the meeting by welcoming the various stakeholders.

The draft minutes of the previous meeting were approved with any comments to be submitted by email to agwatergroup@agriculture.gov.ie before the end of the week.

2. European Court of Auditors Report and Commission Response

Ted Massey gave a brief overview of the recently published Court of Auditors report on "EU efforts for sustainable soil management" which included manure management. In addition he highlighted key elements in the European Commission's response which also had been circulated to the Working Group. He then opened the floor for questions.

3. Workshop on Issues Discussion paper themes

The Working Group divided into 3 breakout groups to discussion a number of questions in relation to each of the following themes:

- Improving awareness and education
- Improving compliance and enforcement
- Reducing N surpluses and addressing nutrient losses to the environment

The Working Group engagement constructively around the themes with a number of useful suggestion emerging from the groups. These will feed into deliberations regarding the Interim Review of the Nitrates Action Programme.

Action: Working Group's suggestions to be fed into Government Department's deliberations regarding the Interim Review.

4. Engagement with the European Commission regarding 220 – Groups views on next steps

The Working Group were advised that engagement with the Commission is on-going and becoming more focussed now the map regarding the two-year review is available. The Chair invited the Working Group to come back by the end of the month with submissions/views regarding what they believe Ireland's ask should be in seeking flexibility regarding the Commission's two-year water quality review and associated restrictions in the maximum stocking rate.

Working Group members made a number of suggestions which included the need to use the best available science to guide approaches to improve water quality, the idea of reducing chemical nitrogen limits rather than livestock manure nitrogen limits and the need to keep farmers on board in terms of the need to improve water quality.

Action: By the end of July, Working Group members are invited to submit views to DAFM regarding what they believe Ireland's ask should be in seeking flexibility regarding the Commission's two-year water quality review.
