In accordance with Section 21A of the Foreshore Act, 1933 (as amended), the Minister of State, Department of Housing, Local Government and Heritage with special responsibility for Planning and Local Government ("the Minister") hereby gives notice that he has determined an application dated 03/06/2021 for a licence under Section 3(1) of the Foreshore Act, 1933 (as amended) made by Farice ehf. Limited ("the Applicant") in respect of installing a Subsea Fibre Optic Cable with landfall at Ballyloughane Strand, Renmore, Galway, route across Galway Bay. An application for leave to apply for judicial review shall be made within three months from the date when grounds for the application first arose under Section 21(1) of the Order 84 of the Rules of the Superior Courts as amended by S.I No 691 of 2011. The time-limit for such a review commences from the Date of Publication of the full Notice of Determination.
