1. Welcome by the Chair and Minutes of the 6th and 7th meetings.

The Chair (Bill Callanan) opened the meeting by welcoming the various stakeholders.

Some members expressed concerns that the previous meeting minutes were not a true reflection of the meeting. The Chair confirmed that would be recorded and sought suggested amendments to the previous meeting's minutes.

2. Communication with Farmers

Ted Massey gave an update on the letters that were issuing to farmers to inform them if, based on parcels they declared for the Basic Income Support for Sustainability Scheme in 2023, all their land would be at 250, 220 or a mix of 220 and 250 kg max organic N/ha in 2024. Templates for the letters will issue to the Group for their information. A nitrates calculator and a FAQ have been provided on DAFM's website.

Some Group members criticised the timing of the letters. Some said they should have issued sooner, while others felt they should have been delayed until after the Commissioner's visit. The Chair reminded members that the EPA map was published at the end of June and the Implementation Map has been available since early October.
