Agriculture Water Quality Working Group

Minutes 9th Meeting – meeting with the European Commissioner

Date: 23rd November 2023, 2:00pm

Vene: Agriculture House, Kildare Street, Dublin 2.

1. Welcome

Brendan Gleeson (Chair) opened and welcomed all to the meeting.

Minister McConalogue thanked the Commissioner and his officials for attending. He signified the importance of improving water quality and appreciated the engagement.

Commissioner Virginijus Sinkevičius then addressed the Group, with the main message that as Ireland is one of only three Member States with a nitrates derogation, being granted a derogation is preferential treatment and the way to keep that derogation is to have stable water quality. He also spoke of his recognition of the importance of the farming sector.

2. Presentation by DAFM

Bill Callanan gave a presentation outlining the justification for Ireland's nitrates derogation, the importance of the derogation to Ireland's grass-based system and family-farm model. Irish water quality and the work through regulation and outside regulation by the sector to improve water quality was also covered.

3. Stakeholders Views

The Chair then opened the meeting to the floor.

Leading representatives spoke. Their statements included their organization's concerns, Ireland's grass-based system and family-farm model, efforts being made to improve water quality as well as what stakeholders are seeking in terms of Ireland's current and future status regarding a nitrate's derogation.

4. Commissioner Sinkevičius' Response

Commissioner Sinkevičius provided the following key messages in response to the Group member's statements:

• There is no change in the timeframe for the move to 220. The decision taken in 2022 can't be reopened. The process of granting a derogation is based on the Commission collecting

- the evidence from the Member States' scientific bodies. The final decision on a derogation must go to the European Nitrates Committee where the Member States then vote.
- Flexibility was given in the exclusion of the area that failed the water quality review tests, but still maintained good water quality status.
- Culling cows is not the only option to adjust to the move to 220. Slurry exports should be utilised as far as possible. Given the 3-month period when slurries are stored in Ireland, there should be potential to move slurry off farms to adjust to a 12% reduction in the limit for application of organic manure on impacted derogation farms.
- If water quality is at least stable and there is political will to grant a derogation, then Ireland has a basis to obtain a derogation post-2025.
- The Commission considers the three sustainability pillars social, economic and environmental in its assessment before putting forward a Member State for a vote regarding a derogation request.
- The Nitrates Directive is over 30 years old and there will soon be an evaluation of the Directive. This stakeholder consultation will provide an opportunity for stakeholders to outline their views. He is seeking stakeholder engagement in the consultation.

5. Close

Minister McConalogue thanked all for attending and pointed to the significance of the visit and how it was unprecedented for a Commissioner to meet stakeholders as he had today. In closing he re-emphasised the importance of Ireland's derogation given Ireland's unique system. He also outlined the clear emphasis being placed on improving water quality with all stakeholders working together to achieve this.
