### **Agenda Item 1:** Opening Remarks

The Chair welcomed the Marine Institute as a new member of the Taskforce, represented by interim CEO Mick Gillooly.

# **Agenda Item 2:** Adoption of Update Terms of Reference (ToR)

The revised Terms of Reference for the Taskforce were adopted, and it was noted that they provided for Taskforce minutes to be published on gov.ie going forward.

# Agenda Item 3: Update on Workstreams by exception

Workstreams 1A (Marine Planning, Regulations & Guidelines), 1B (Marine Biodiversity, Designation & Assessment), 1C (ORE Consenting and Regulatory Framework)

MM updated the group on progress made in relation to Workstream 1, including:

 amendments to the MAP Act through commencement of relevant provisions of the Historic and Archaeological Heritage and Miscellaneous Provisions Bill 2023 which are due by the end of the year; and



 the Seafood-ORE Group is due to issue its interim report in Q1 2024, which will include recommended actions for 2024.

#### Workstream 2 - Future Framework

EB updated the group on progress made in relation to Workstream 2, including:

- work is continuing on the draft Future Framework policy, with screening for SEA/AA due to be undertaken shortly, with a public consultation planned for early 2024;
- the first draft of the SEAI Roadmap has been completed, with a consultation due to take place in January 2024; and
- a new action to develop an Offshore Transmission Strategy, with its remit to include work on multiconnection, offshore bidding zones, pilot projects and energy clusters for hydrogen hubs.

#### Workstream 3 - Communications

PG updated on progress made in relation to Workstream 3, including:

- in relation to the Irish Pavilion at Wind Europe, and the potential for this event to include a number of ORE policy launches;
- work to enhance internal communications across the Taskforce; and
- plans for stakeholder engagement in relation to the next stage of the South Coast DMAP proposal.

#### Workstream 4 - ORESS

DC updated on progress made in relation to Workstream 4, including:

- work on drafting the Terms and Conditions for ORESS 2.1, with the team working towards a publication in March in line with the indicative roadmap scenarios published in November; and
- an industry information session will be held in January 2024.

### Workstream 5 – Grid Development including Licensing/Regulation

PM updated on progress made in relation to Workstream 5, including



- engagement in relation to the South Coast DMAP;
- engagement with WEI and developers on Phase 2; and
- working with developers with respect to ORESS 1 FEED designs finalised.
- EirGrid undertook engagement with SEAI with respect to the technology roadmap and AMETS.

#### Workstream 6 - Maritime Transport/Commercial Ports Policy

EK updated on progress made in relation to Workstream 6, including:

- ports engagement with MARA;
- an agreement with the EIB in relation to proposed studies of a number of ports and potential financing of ORE infrastructure;
- EU Connecting Europe Facility (CEF) Transport Call for infrastructure and studies funding, which closes on 30 January 2024; and
- the National Ports Policy Review, the consultation on which will close on 15 January 2024.

#### Workstream 7 – Supply Chain

JMcD updated on progress made in relation to Workstream 7, including

- Gary Tobin has replaced David Hegarty as the new Assistant Secretary for the Enterprise Strategy, Competitiveness and Evaluation Division; and
- development of the National Industrial Strategy for Offshore Wind as well as stakeholder engagement which will feed into the strategy's development, including the Industry Forum and meetings with organisations such as WEI, EI, and IDA.
- MC also confirmed that EI had good engagement with EirGrid in relation to procurement matters and emphasised that a Memorandum of Understanding between both parties will be very beneficial to boost supply chains.

#### Workstream 8 - Skills and Workforce

IP updated on progress made in relation to Workstream 8, including that



- the skills assessment report commissioned by Greentech Skillnet is expected to be finalised shortly; and
- the structure of the Expert Advisory Group for Offshore Wind Skills and Workforce is being revised to provide for subgroups focusing on specific matters.

### Agenda Item 4 - OWEP review

IP thanked Taskforce Members and their teams for their input into the review of actions in the Offshore Wind Energy Programme. A significant change is the creation of two new workstreams: workstream 9 will focus on data acquisition and workstream 10 will focus on DMAP designation. JC gave an overview of workstream 9, noting that the workstream has two main strands; a surveying strand and a data strand. RMcG underlined the significance of the Workstream noting that understanding ORE data would be fundamental to the progress of the OWEP.
