**Agriculture Water Quality Working Group** 

Minutes 13th Meeting

**Date:** 15<sup>th</sup> January 2024, 9:30am

1. Welcome by the Chair and Minutes of 12th meeting, 20/12/23

The Chair (Louise Byrne) opened the meeting by welcoming the various stakeholders. The minutes of

the previous meeting were agreed.

2. **Update on Teagasc research** 

DAFM informed the Group that since the last meeting Teagasc presented data regarding excretion

rates broken down by gender for 1-2 year old cattle. For a female 1-2 old, the data shows a slight

reduction, while it shows a slight increase for her male counterpart. The Group had mixed views

regard whether a distinction should be made based on gender. Some stakeholders felt in the interest

of minimising complexity for farmers one average value should continue to be used for the 1-2 year

old category. Other stakeholders felt a distinction should be made based on gender. The matter

needs further consideration.

DAFM informed the Group that UCD have conducted their peer review of Teagasc's work regarding

crude protein in concentrates and the nutrient excretion rate for young bovines. UCD provided

positive feedback. They have made some comments that they feel could lead to a strengthening of

the documents. These comments have gone to Teagasc who are expected to respond shortly.

The process regarding Appropriate Assessment for these measures was outlined to Group. Some

stakeholders expressed concerns regarding any delays to implementation of the measures. DAFM

outlined its objective that the measures would apply for the full year. DHLGH are to seek clarification

regarding whether the changes to excretion rates can apply for the full year if signalled early.

Action: DHLGH to seek clarification regarding whether the changes to excretion rates can

apply for the full year if signalled early. DAFM to liaise with DHLGH on this.

## 3. Finalisation of Group's Recommendations to improve water quality under the Interim Review

The Chair thanked those who submitted written comments over the previous week. The document had been updated to reflect those written comments.

The Group discussed the updated document focusing on the updated text and areas where there had not been an agreed recommendation arising from the previous meeting.

The Group's views and recommendations were added to the document as the discussion progressed. DAFM agreed to update the document further where necessary based on the Group's views and to circulate to the Group on 16/01/24.

**Action:** Secretariat to develop and circulate updated document by 16/01/24.

**Update:** Update document circulated for comments on 16/01/24.

**Action:** Group to provide written comments on the document by 17/01/24.

**Update:** Group members responded with feedback. These suggested changes were incorporated as far as possible and the final draft showing tracked changes was circulated to the Group on 22/01/24 seeking their endorsement.

## 4. Update from Meeting with Commission Services

DAFM and DHGLH officials outlined that while they were in Brussels in December, they had a separate bi-lateral meeting with Commission Officials. During that discussion Ireland sought clarification regarding Commissioner Sinkevičius' comments about the need for stable water quality compared to the point made previously by Commission Officials about water quality having to be good and improving for a future derogation to be granted. The Group were advised that the Commission Officials clarified the position by stating that where water quality is good it needs to be stable, and where water quality is poor, it needs to be improving for a derogation to be granted.

In response, members of Group confirmed their previous position regarding the need for the sector to work towards improving water quality. They also outlined the need for them to fully understand what is meant by good water quality and the context of how it is monitored. It was agreed this would be put on the agenda for the next meeting.

The Group were also informed that the European Commission has opened a public consultation regarding an evaluation of the Nitrates Directive. The matter will be discussed in more detail at the next meeting.

**Action:** Secretariat to include the evaluation of the Nitrates Directive and understanding and communicating water quality as Agenda Items for the next meeting.

## 5. AOB and date of next meeting

No points were raised under AOB.

The next meeting will take place on 29/01/24, in Portlaoise. Details will follow when venue is confirmed.
