











The Sligo Local Community Development Committee (LCDC) will be the Local Action Group (LAG) for the delivery of the Rural Development Programme working in partnership with LAG Partners Sligo County Council and Sligo LEADER Partnership Company. The total budget available for Sligo is €7,655,647.

The LCDC has been established for the purposes of developing, coordinating and implementing a coherent and integrated approach to local and community development. The committee is made up of representatives from the local government and local development sectors, public bodies and representatives of social, economic, environmental and community interests.

The decision on the approval of projects for the Rural Development Programme will be made by Sligo Local Community Development Committee (LCDC) as the Local Action Group. (LAG)

On the 25th February 2016 the LEADER Independent Selection Committee (ISC) approved the Local Development Strategy (LDS) for the County Sligo sub-regional area. This strategy will form the basis for all project approvals.
