- Based on the results of the National Residue Control Plan on harmful substances in accordance with 6. Regulation (EU) 2017/625, pig meat from which products are derived does not contain residues and is free from nitrofurans, beta agonist and chloramphenicol.
- 7. The pork meat or pork products have been processed, packed and stored under sanitary conditions and do not contain any preservatives, colouring matter, residue or any foreign substance or harmful material injurious to health and every precaution has been taken to prevent contamination during processing, packing, storing and handling prior to export.
- 8. The pork meat or pork products destined for export to Malaysia are safe, wholesome and fit for human consumption.
