#### **Background:**

After qualifying as an accountant, Martin joined Scottish and Newcastle Breweries in 1978 where he held various accounting positions before joining Center Parcs Ltd in 1995 as UK Financial Controller.

In 1997 he became Finance Director of Center Parcs UK, going on to be promoted to Chief Executive Officer in July 2000.

Martin has led the UK business through the change of company ownership from Scottish and Newcastle to Deutsche Bank Capital Partners (subsequently MidOcean Partners) in March 2001; as well as the acquisition and integration of a fourth Village, (now known as Center Parcs Whinfell Forest), into the business.

He subsequently led the float of the business onto AIM in December 2003; the transition to the London Stock Exchange's main list in March 2005; the purchase of the business by The Blackstone Group in May 2006 followed by the subsequent sale of the business to Brookfield Property Partners in August 2015.

More recently, Martin was heavily involved in Center Parcs' development of its first village outside of the UK, in County Longford, Ireland. Longford Forest successfully opened to guests in July 2019.

#### **Background:**

Over 11 million overseas visitors in 2019 contributed over €5.8BN to the island economies and supported 325,000 jobs.
