



**Screening Determination for Appropriate Assessment
Of The
Statutory Climate Change Adaptation Plan for the Electricity and Gas Networks
Sector**

In accordance with Article 6(3) of the EU Habitats Directive (Directive 92/43/EEC) and Regulation 42(1) of the European Communities (Birds and Natural Habitats) Regulations 2011 as amended, The Minister for Communications, Climate Action and Environment has undertaken screening for the need for Appropriate Assessment to assess, in view of best scientific knowledge and the conservation objectives of site(s), if the Statutory Climate Change Adaptation Plan for the Electricity and Gas Networks Sector, individually or in combination with other plans or projects is likely to have a significant effect on a European site(s).

In accordance with Regulation 42(7) of the European Communities (Birds and Natural Habitats) Regulations 2011 as amended, the Minister for Communications, Climate Action and Environment, has made a determination following screening that an Appropriate Assessment is not required.

This determination was based on the assessment that the Plan is not directly connected with or necessary to the management of any European Site and it can be excluded on the basis of objective scientific information that the Plan, individually or in combination with other plans or projects will have a significant effect on a European Site.

This determination was reached based on nature of the Plan which is that of a policy statement showing the general intention of the Department for application by the Electricity and Gas Networks Sector. As such it does not fall under the definition of a Plan for the purpose of Article 6(3) and Screening for AA is not a requirement. The Plan does not set out location specific recommendations and therefore there is no link between the content of the plan and any likely significant effects on European Sites.

Bunaíodh an cinneadh sin ar an measúnacht nach bhfuil gá leis an bPlean ná nach bhfuil nasc díreach ag an bPlean maidir le bainistiú a dhéanamh ar Láithreán Eorpach ar bith agus gur féidir é a chur as an áireamh ar bhun na faisnéise eolaíochta oibiachtúla go mbeidh tionchar suntasach ar Láithreán Eorpach ag an bPlean, as féin nó i gcomhar le pleannanna nó tionscadail eile.

Thángthas ar an gcinneadh sin bunaithe ar nádúr an Phlean, is é sin ráiteas beartais ina léirítear rún ginearálta na Roinne atá le cur i bhfeidhm ag Earnáil na Líonraí Leictreachais agus Gáis.
