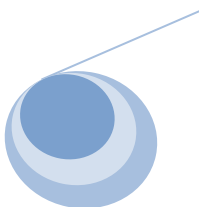

- In order to be approved as a plant involved in the storing of former foodstuffs where endusage includes feed or petfood, the applicant must be approved by the Department of Agriculture, Food and the Marine (DAFM) and hold a valid certificate of approval in accordance with (Article 24 (h) of EC Regulation 1069/2009).
- ‘CN5 – Conditions for the approval of handling and storage plants (Former Foodstuffs) where endusage includes feed or petfood’ can be found [here](#) and must be read before completing this application form.
- All personal data processed by the Department of Agriculture, Food and the Marine will take place in accordance with the law on Data Protection and will only be for the purposes connected to the functions of this Department. More information can be found [here](#).
- **Please note:** The application form must be completed by the ‘operator’. The operator is defined as ‘the natural or legal persons having an animal by-product or derived product under their actual control, including carriers, traders and users’.
