### Please note the following:



- In order to be approved as a plant/establishment carrying out intermediate activities and storing animal by-products, the applicant must comply with the European Communities (Animal By-Products) Regulations 2014 (S.I. No. 187 of 2014) and operate in accordance with Regulation (EC) No. 1069/2009 and Regulation (EU) No. 142/2011.
- <u>`CN32 Conditions for approved plant/establishment carrying out intermediate activities</u> and store animal by-products (except Category 3 processed PAP and Knackeries)',
   <u>`CN32a - Conditions for a plant/establishment approved to store Category 3 processed</u> animal protein (PAP)` and <u>`CN32c - Conditions for a plant/establishment approved to</u> carry out intermediate activities and store horse placenta` must be read before completing this application form.
- All personal data processed by the Department of Agriculture, Food and the Marine will take place in accordance with the law on Data Protection and will only be for the purposes connected to the functions of this Department.
- **Please note:** The application form must be completed by the 'operator'. The operator is defined as 'the natural or legal persons having an animal by-product or derived product under their actual control, including carriers, traders and users'.

- Applications that are incomplete, that contain insufficient or unsatisfactory information or that do not comply with conditions or legislative requirements will be returned to the applicant and a revised, fully completed application must be re-submitted.
