Provision of a pontoon and access gangway to facilitate transport of visitors to Sliabh Liag (highest sea cliffs in Europe). The deployment of a pontoon and access gangway is necessary to accommodate the increased visitor numbers to the area. The major development of the Siabh Liag Visitor Centre and the Wild Atlantic Way marketing campaign by Failte Ireland, has resulted in increased visitor numbers to this area of Donegal and these are projected to significantly increase in the coming years. It is essential to provide safe and easy access to marine leisure craft from the pier that conform to EU regulations and to make these facilities accessible to all including disabled visitors who wish to partake in marine leisure activities. The pier steps currently in use by visitors boarding boats are not acceptable for passengers boarding any marine leisure craft. It is proposed to have the pontoon in place from 1st May to 30th September each year and stored on shore during winter months.

1.2 Description of proposed works/activity/event

 $15m \log x$ 3m wide pontoon with glass reinforced concrete (GRC) decking and $15m \log x$ 1.2m wide access gangway with glass reinforced plastic (GRP) decking connected to existing pier. This will be placed on a temporary basis from 1^{st} May to 30^{th} September each year and removed completely from vicinity of pier during winter months.

1.3 Indicative timing of the works/activity: (i) Start date (ii) Duration (iii) Any other information relevant to timing.

To be placed in November 2014 on trial basis and removed for winter storage to return on 1^{st} May 2015.

1.4 Might the proposed works restrict public use/enjoyment of the foreshore? Provide details.

The proposed works will not restrict current use/enjoyment of the foreshore. It will enhance existing facilities and make them more appropriate for the type of craft currently using the facilities. As well as commercial fishing, angling and chartered boat trips take place from this pier with regular boat trips to view the cliffs of Sliabh Liag.
