### **LOCAL AUTHORITY CHIEF EXECUTIVES (REMUNERATION) (No. 2) ORDER, 2017**

In exercise of the functions conferred on the Minister for Housing, Planning and Local Government by Chapter 4 of Part 14 of the Local Government Act, 2001 (No. 37 of 2001), which said functions have been delegated to me by the said Minister by virtue of section 236 (7) of the said Act, I, Paul Lemass, Assistant Secretary, Department of Housing, Planning and Local Government, hereby direct and order as follows:

1. This Order may be cited as the Local Authority Chief Executives (Remuneration) (No.2) Order, 2017.
2. Until the Minister for Housing, Planning, and Local Government otherwise determines –
  - (a) the remuneration of the holder of the office of Chief Executive for the local authority named in Part I of the Schedule hereto shall be an annual salary at the rate –

as from the 1<sup>st</sup> day of January 2018 of €182,141
  - (b) the remuneration of the holder of the office of Chief Executive for each of the local authorities named in Part II of the Schedule hereto shall be an annual salary at the rate –

as from the 1<sup>st</sup> day of January 2018 of €156,293
  - (c) the remuneration of the holder of the office of Chief Executive for each of the local authorities named in Part III of the Schedule hereto shall be an annual salary at the rate –

as from the 1<sup>st</sup> day of January 2018 of €147,930
  - (d) the remuneration of the holder of the office of Chief Executive for each of the local authorities named in Part IV of the Schedule hereto shall be an annual salary at the rate –

as from the 1<sup>st</sup> day of January 2018 of €137,629

- (e) the remuneration of the holder of the office of Chief Executive for each of the local authorities named in Part V of the Schedule hereto and of the office of Dublin Assistant Chief Executive and of the office of Head of Human Resources in Dublin City Council and of the office of Head of Finance in Dublin City Council shall be an annual salary at the rate –

as from the 1<sup>st</sup> day of January 2018 of €128,102
